UNIVERSITY NOTICE, 2002  
(Under Section 3)

In exercise of the powers conferred by Section 3 of the Commission of Enquiry Act, 1963 the Minister for Education makes the following Notice.

***Citation and Commencement***

1. This notice may be cited as The Commission of Enquiry into the Affairs of the University Notice, 2002 and shall come into force on the publication of the Gazette.

***Establishment and Composition***

2. There is hereby established a Commission of Enquiry into the University Council (hereinafter referred to as the Commission ) which shall be composed of the following persons-

Mrs Lindiwe Khumalo-Matse	- Chairperson
Mr. Timothy Nsingwane	- Member
Mr. Gilbert Mabila	- Member
Ms. Treasure Maphanga	- Member
Mr. Solomon Simelane	- Member
Mr. Vusi Dlamini	- Secretary

***Functions of the Commission***

3. The Commission shall perform the following functions-

- (a) investigate the University policies in relation to implementation;
- (b) Investigate the administrative, recruitment, retention criteria and practice used to the University personnel;
- (c) investigate the criteria and practice used for promoting staff;
- (d) investigate the adequacy of qualifications of academic staff carrying out university programs;
- (e) investigate academic standards for relevance considering international comparability;
- (f) investigate research facilities and their use;
- (g) investigate the adequacy of resources in supporting academic programs
- (h) investigate the management and inventory of stores and equipment and disposal systems,
- (i) investigate any other matter which the Commissioners may determine to be appropriate; and
- (j) make recommendations on the basis of their findings.

***Period to be covered***

4. The Commission shall consider the operations of The University for the last 10 years.

***Enquiry Venue***

5. The enquiry shall be held at such places and times, as the Chairperson shall determine.

***Enquiry to be in Camera***

6. Unless the Minister otherwise directs, the proceedings of the enquiry shall be held in camera.

***Quorum***

7. Four members including the Chairperson shall constitute a quorum for the purpose of enquiry.

***Submission of Final Report***

8. The Commission shall present its final report to the Minister within one month.

***Extension of Time***

9. The Minister may, from time to time extend the period of the enquiry by notice published in a Gazette.
