LEGAL NOTICE NO. 129 OF 2002

THE WAGES ACT, 1964
(Act No. 16 of 1964)

THE APPOINTMENT OF MEMBERS OF THE WAGES COUNCILS NOTICE , 2002
(Under Section 6)

In exercise of the powers conferred by section 6 of the Wages Act, 1964, the Minister for Enterprise and Employment makes the following Notice-

Citation and Commencement

1. This Notice may be cited as the Appointment of Members of the Wages Council Notice, 2002 and shall be deemed to have come into force on the 31st August, 2002.

Appointment of Members

2. (1) The persons listed in the Schedule to this Notice are appointed members of Wages Councils with effect from the 31st August, 2002 to 1st September, 2005.

(2) Any independent member of the Wages Council may act as Deputy Chairperson in the absence of the Chairperson of any Wages Council.

(3) The Senior Labour Inspector (Ben Simelane) or his alternative shall be Secretary to the Wages Councils.

Allowances and Fees

3. Members of the Council including the Secretary shall be paid such allowances as are paid to statutory bodies.
