# THE CONSTITUTION OF SWAZILAND, 1968 (Act No. 50 of 1968)

# THE PRESCRIPTION OF STATUTORY SALARIES AND ALLOWANCES NOTICE, 2002. (Under Section 131)

In exercise of the powers conferred by section 131 of the Constitution of Swaziland, 1968, as repealed with savings, the Minister for Finance hereby issues the following Notice-

## Citation and Commencement.

1. This Notice may be cited as the Prescription of Statutory Salaries and Allowances Notice, 2002, and shall be deemed to have come into force on the 1st April, 2002.

# Prescription of salaries and allowances.

2. Without prejudice to any other benefits conferred by any law, the holder of an office specified in the first column of the Schedule shall be paid not less than the salary or allowance or both (as the case may be) specified in relation to the holder, in the second, third, fourth, fifth, sixth, seventh and eighth columns of the Schedule.

# Revocation of Legal Notices

3. Legal Notices No. 78 of 1999, and No. 99 of 1999, are hereby revoked to the extent that those Legal Notices affect the holders of offices specified in the first column of the Schedule.
