(Kings-Order-in-Council No. 1 of 2004)



I ASSENT

19th September, 2003

A KINGS-ORDER-IN COUNCIL entitled

An Order to amend the Central Bank of Swaziland Order, 1974.

ENACTED by the King in collaboration with the Council.

Short title and Commencement.

1. This Order shall be cited as the Central Bank of Swaziland (Amendment) Order, 2004 and shall be read as one with the Central Bank Order, 1974 (hereinafter referred to as "the Order"), and shall come into operation on such date as the Minister may, by notice published in the Gazette, appoint.

Amendment of Section 23.

- 2. Section 23 of the Order is amended by:
 - (a) renumbering the existing paragraph as subsection (1); and,
 - (b) inserting thereafter the following new subsection (2):
 - "(2) Notwithstanding subsection (1), the Minister may, after consultation with the governor, by notice published in the Gazette, declare any currency, other than the lilangeni, to be legal tender in Swaziland."
