**COMMENTARY****OVERVIEW**

Headlines earnings per share have increased by 71% and profit after tax improved by 63% for the year ending 31<sup>st</sup> December, 2003 relative to prior year, 21% of this growth is attributable to the impact of current IAS39 adjustments. This is evident by the reversal of SZL5.8million advances impairment.

A 5% drop in prime during the year has placed the Bank's margins under pressure, however growth in assets as well as a focus on margin management has contributed to a 25% increase in net interest income. Non-interest revenue has grown by 17% as a result of increase in the suite of products and volume of business.

**ACCOUNTING POLICIES**

The financial statements for the year ended 31 December 2003 have been prepared in accordance with Swaziland and International Financial Reporting Standards and in the manner required by the Swaziland Companies Act 1912, as amended. The accounting policies are consistent with those of the previous year.

**CAPITAL ADEQUACY**

The directors are satisfied that the bank is well capitalised and meets the Regulatory Authority requirements.

**CORPORATE GOVERNANCE**

The directors and management of Nedbank (Swaziland) Limited confirm their commitment to the principles of openness, integrity and accountability as advocated by sound principles of Corporate Governance.

**DIRECTORS**

During the year, Mr Z. M. Nkosi was appointed Chairman of the Board, after the sad loss of the previous Chairman, Mr A R B Shabangu. On 14 August 2003, the bank suffered the untimely loss of its Managing Director, Mr D.Q. Pretorius. His contribution to the performance of the bank is acknowledged and will be missed in the future. Mr A.M Dlamini was appointed to the position of Managing Director with effect from 13<sup>th</sup> November 2003.

Resignations: Mr W.P.Frost (16 September 2003), Mr C D Nelson (28<sup>th</sup> October 2003), Mr A Redelinghuis an alternate director (11 September 2003). Their resignation is not related to Corporate Governance issues

Other appointments: Mr S M Pityana (13 November 2003), Mr C Drew (1December 2003).

The remaining composition of the Board was maintained.

## **PROSPECTS**

The consistent application of our business model and strategy is proving successful and we intend to continue therewith. The bank will continue focusing on customer satisfaction by improving the quality of service and increasing the suite of products offered to Retail and Corporate clients, which we see as our main differentiator in the market.
