#### THE APPOINTMENT OF THE SMART PARTNERSHIP HUB TASK FORCE (Under Section 3)

In exercise of the power conferred by Section 3 of the Commission of Enquiry Act, 1963, the Prime Minister issues the following Notice :

#### ***Citation and Commencement***

1. This Notice may be cited as the Appointment of The Smart Partnership Hub Task Force, 2005, and shall be deemed to have come into force on the 1<sup>st</sup> May 2005.

#### ***Establishment and Appointment of Members of the Task Force***

2. There is hereby established a Task Force to be known as the Smart Partnership Hub Task Force and shall consist of the following Members :

#### ***Functions of The Task Force***

3. The Task Force shall assist in the establishment and operationalisation of the Smart Partnership Hub. Specifically, the Task Force shall do the following :

- (a) Recommend the appointment of a Chief Executive Officer, and Senior Staff of the Hub;
- (b) Recommend the links to constitute the Smart Partnership Hub;
- (c) Recommend the effective and efficient means of managing and marketing of the Marquees;  
and
- (d) Prepare and submit a comprehensive way forward on Hub activities.

***Meetings***

4. (a) The Task Force shall meet at a place and times as the Chairperson of the Task Force shall determine.
- (b) The Task Force shall make its own rules for the regulation of its business and procedures relating to its meetings.

***Powers of the Task Force***

5. The Task Force shall have power to call any person, including Government Ministries and other institutions, to make submissions on any issue relating to the functions of the Task Force, and to perform any task that the Task Force may assign.

***Allowances and Reimbursements***

6. The Members of the Task Force shall be entitled to sitting allowances as the Minister may determine, and, where applicable, to reimbursement for travel Expenses.

***Duration***

7. The appointees shall remain Members of the Task Force for a period not Exceeding four (4) months, except where the Prime Minister, by Notice in the Gazette, terminates or extends their appointments.
