THE ROADS AND OUTSPANS (AMENDMENT) BILL, 2005 (Bill No. 8 of 2005)

(To be presented by the Minister for Public Works and Transport)

MEMORANDUM OF OBJECTIVES AND REASONS

The object to this Bill is to enable the introduction of a roads tolling system in Swaziland in order to-

- (a) provide for the declaration to Toll roads;
- (b) provide for the declaration of Toll tariffs as user charges;
- (c) provide for the establishment of a Toll Road Account as a special fund for toll roads;
- (d) regulate the payment of tolls into the Toll Road Account and the equitable disbursement of monies from the Toll Road Account for toll roads;
- (e) provide for collection of toll tariffs by any public or private agent;
- (f) provide for the deployment of private capital in toll roads works;
- (g) amend the Roads and Outspan Act, 1931; and
- (h) to provide for matters incidental thereto.

A BILL entitled

AN ACT to provide for the introduction of a road tolling system in Swaziland and other matters incidental thereto.

ENACTED by the King and the Parliament of Swaziland

Short title and commencement

1. This Act may be cited as the Roads and Outspans (Amendment) Act, 2005 and shall be read as one with the Roads and Outspans Act, 1931 (hereinafter referred to as the "principal Act") and shall come into force on a date to be appointed by the Minister by Notice in the Gazette.

Amendment of section 2

2. Section 2 of the principal Act is amended by inserting the following-

"Toll Road Account" means the account established in terms of section 25bis;

“toll road agency” means any department or division of any ministry of the Government, any public entity established in terms of the laws of the country or any public enterprise established by the Government pursuant to the provisions of the Public Enterprises (Control and Monitoring) Act, 1989, that has been appointed or established with the purpose of providing support to the Minister in respect of the implementation of toll roads in the country;

“toll” means an amount payable by users of a toll road as determined by the Minister in terms of section 7ter, and “tolls” and “tolling” has a similar meaning;

“toll plaza” means a structure on a toll road where a toll is payable under this Act, or any electrical or mechanical device on a toll road for recording the liability to pay toll, or any combination of such a structure and such a device and includes a toll gate;

“toll road” means any road or a portion thereof which has been declared a toll road under section 7bis and on which all or some categories of road users shall pay a toll as determined by the Minister upon recommendation of the Head of the Roads Department and published by way of notice in the Gazette under section 7ter.”

Insertion of section 7bis, 7ter and 7quater

3. The principal Act is amended by the inserting of the following new sections 7bis to 7quater.

“Levying of toll

7bis. (1) The Minister may declare a public road or any portion thereof, including any bridge or tunnel on a public road, as a toll road, for the purposes of this Act and amend or withdraw any such declaration.

(2) A public road or portion thereof shall not be declared a toll road unless-

- (a) a local authority affected by the declaration has been consulted; and
- (b) an invitation contemplated in subsection (4) has been published in the Gazette.

(3) The Ministry may-

(a) levy a toll in respect of the driving or use of any vehicle on a toll road, the amount of which has been determined and made known in terms of section 7ter and which is payable at a toll plaza by the person so driving the vehicle, or at any other place subject to such conditions as the Minister may determine;

(b) grant exemption from the payment of a toll on a particular toll road-

- (i) in respect of a vehicle of a category determined by the Minister, or in respect of any such vehicle used on the toll road, at a time so determined; or
- (ii) to a person of a category determined by the Minister, irrespective of the vehicle used by such person on the toll road, or to any such person using a vehicle on the toll road at a time so determined;

(c) restrict the levying of toll on a particular toll road to specific hours or other times;

- (d) suspend the levying of toll on a particular toll road for a specified or an unspecified period and in respect of all vehicles or in respect of vehicles of a category and resume the levying after a suspension; and
 - (e) withdraw any such exemption, restriction or suspension.
- (4) For the purposes of this section, the Minister shall by notice in the Gazette make known an intention to declare a toll road or exempt, restrict and suspend payment of a toll or withdraw any such declaration, exemption, restriction and suspension and such notice shall -
- (a) in the case of declaration of a toll road, indicate the approximate position of the toll plaza contemplated for the proposed toll road; and
 - (b) invite any person affected to lodge written representations in relation to the Minister's intention within 14 days from the date of the notice.
- (5) The Minister shall consider any comment received pursuant to the invitation contemplated in subsection (4) and publish a declaration, exemption, restriction, suspension or withdrawal by notice in the Gazette, which notice shall specify-
- (a) the date on which any declaration, exemption, restriction, suspension and withdrawal shall become effective; and
 - (b) the manner in which comment has been accommodated or, if comment has not been accommodated, specify the reason thereof.

Toll tariff

- 7ter* (1) The Minister shall, on recommendation of the roads agency, from time to time, determine -
- (a) the maximum amount or amounts of the toll that may be levied under section 7bis; and
 - (b) the date and time from which a toll shall be payable.
- (2) The amount of toll levied in terms of subsection (1), any discount thereon and any alteration thereof may vary in respect of-
- (a) different toll roads;
 - (b) different vehicles or different categories of vehicles driven on a toll road;
 - (c) different times at which any vehicle or any vehicle of a particular category is driven on a toll road; or
 - (d) different persons or different categories of persons, irrespective of the vehicle driven by such persons.
- (3) For the purpose of this section, the toll roads agency shall by notice in the Gazette make known-
- (a) the amount of the toll that may be levied in relation to a specified road and

classes of persons and vehicles;

- (b) the date and time from which the toll shall be payable and that such date may not be earlier than 14 days after the date of the notice published in the Gazette; and
- (c) the hours during which the toll shall be levied.

Refusal to pay toll and offence

- 7quater.* (1) A person who refuses to pay the amount of toll at a toll plaza or at any other place contemplated in section *7bis*, for which the person is liable in terms of that section, commits an offence.
- (2) In any criminal proceedings at which a person is charged with a contravention under this section it is presumed, unless the contrary is proved, that the vehicle alleged to have been driven in committing such contravention, was driven by the registered owner thereof."

Insertion of sections 25bis, 25ter, 25quater, 25quinquies, 25sexies

4. The principal Act is amended by inserting the following new sections *25bis* to *25 sexties*.

"Establishment of Toll Road Account

- 25bis.* (1) The Minister shall establish a Toll Road Account in respect of each toll road declared as such in terms of section *7bis* within seven days after such declaration -
- (a) to serve as a single channel for the receipt and disbursement of tolls;
 - (b) to provide a transparent mechanism to allocate and disburse tolls to an appropriate roads authority in respect of the toll road from which the tolls accrue; and
 - (c) to ensure that financial discipline and accountability are entrenched.
- (2) The revenue of the Toll Road Account comprises money derived from -
- (a) tolls;
 - (b) appropriations by Parliament including loans made available by Parliament in respect of each toll road declared as such in terms of section *7bis*;
 - (c) interest on the Toll Road Account's cash balances; and
 - (d) any other source in terms of the provisions of any Act.
- (3) The Toll Road Account is a special fund as contemplated in section 12 of the Finance and Audit Act, 1967.

Management of Toll Road Account

- 25ter.* (1) The Minister is accountable for and shall manage the Toll Road Account in accordance with the provisions of this Part.

- (2) The Minister may be assisted by a toll roads agency in exercising the powers and performing the functions related to the management of the Toll Road Account.
- (3) The conditions of service, including remuneration, of staff of a **toll roads agency appointed by the Minister** as contemplated in subsection (2), shall be determined by the Minister **with approval of the Cabinet Standing Committee on Public Enterprises pursuant to section 10 of the Public Enterprises (Control and Monitoring) Act, 1989.**

Collection of tolls and payment into Toll Road Account

- 25quater.(1) The Minister **or the toll roads agency with approval of the Minister**, may appoint any person to collect tolls at places determined by the Minister by notice in the Gazette.
- (2) The Minister **or the toll roads agency** shall issue a certificate of appointment to a person contemplated in subsection (1) and publish the name of such person in the Gazette and in at least one newspaper of national circulation.
 - (3) A collection agent shall produce a certificate of appointment issued in terms of subsection (2) upon the request of any road user.
 - (4) Tolls collected, including interest on such monies, shall be paid directly into the Toll Road Account at regular intervals and for this purpose the Minister shall, in consultation with the Minister responsible for finance, prescribe the intervals at which and manner in which such revenue is paid into the Toll Road Account by notice in the Gazette.
 - (5) A person appointed in terms of subsection (1) may be reimbursed from the Toll Road Account for undertaking the function of collecting tolls on basis determined by the **Minister upon recommendation by the toll roads agency and with the approval of the Cabinet Standing Committee on Public Enterprises.**

Application from the Toll Road Account

- 25quinquies.(1)The **toll roads agency** shall, at least four months before the commencement of each financial year, in such form as may be determined by the Minister, submit a funding application, containing a management plan in respect of a toll road or toll roads, as the case may be, for the ensuing financial year and the ensuing five financial years, with information on -
- (a) each project or programme which the appropriate roads authority proposes to undertake, including the estimated total cost of that project or programme, the cost of contingencies and administrative expenditure relating to such project or programme;
 - (b) each project approved in any previous financial year and which is to be continued in the next financial year or in any of the five financial years;
 - (c) the estimated administrative expenditure of the appropriated roads authority' including the cost of contingencies, to the extent that such expenditure was not included in the cost of a project or programme referred to in paragraph (a) and

- (d) any factors, including environmental factors, which may affect the implementation of the one year and the five year plan concerned and the measures which shall be taken to ensure execution of any such plan.
- (2) The Minister shall, after consideration of every plan submitted in terms of subsection (1), determine the amount of funding to be made available to the **toll roads agency**.
- (3) The Minister may pay any amount of funding due to **the toll roads agency** in such instalments and subject to such conditions as the Minister may determine.
- (4) The Minister may impose a requirement that funds may only be disbursed upon certification that work has been executed according to specification.

Utilization of funds disbursed from the Toll Road Account

25*sexies*. Monies disbursed to the **toll roads agency** from the Toll Road Account in accordance with section 25*quinquies* may only be used –

- (a) to execute works on the toll road from which such monies accrue including but not limited to -
 - (i) planning, design, construction, management, rehabilitation, upgrading, maintenance and operation of roads, related systems, developments and associated facilities;
 - (ii) road traffic law enforcement, including the control of vehicle overloading;
 - (iii) research; and
 - (iv) any other work and services related thereto.
- (b) to pay off any loan in respect of a toll road and the payment of interest on such a loan.

Financial controls

25*septies*. (1) The Minister **and the toll roads agency** shall-

- (a) cause full records to be kept of all transactions of the Toll Road Account; and
 - (b) as soon as possible, but not later than three months after 31 March of each year, cause the books and accounts relating to the transactions of the Toll Road Account to be balanced as at that date and thereafter prepare a statement showing in all necessary detail the income and expenditure of the Toll Road Account during the preceding financial year and a balance sheet showing the assets and liabilities of the Toll Road Account as at the end of that year.
- (2) The accounts and balance sheet of the Toll Road Account shall be audited annually by the Auditor-General.

- (3) The Minister shall table a copy of the audited accounts and balance sheet of the Toll Road Account in Parliament within 14 days after it has been received by the Minister if Parliament is then in ordinary session or, if Parliament is not then in ordinary session, within 14 days after the commencement of its next ordinary session.”

Insertion o section 26bis

5. The principal Act is amended by inserting section 26bis.

“Provision, management and operation of toll road infrastructure and related services by an authorised person

- 26bis. (1) The Minister **or the toll roads agency upon approval by the Minister** may, in terms of an accountable and transparent procurement process conclude a contract to authorise any person to provide, operate, manage, control, maintain, rehabilitate and upgrade a toll road or any portion thereof that has been declared a toll road in terms of section 7bis, or any related facility.
- (2) The appropriateness of any contract contemplated in subsection (1) shall be determined with reference to viability criteria determined by the Minister or the **toll roads agency upon approval by the Minister** from time to time.
- (3) The provisions of any contract contemplated in subsection (1) may include-
- (a) the right to develop associated facilities and undertake related development projects; and
 - (b) the authorisation of a contractor who operates a toll road to assist with law enforcement where capacity is insufficient to enforce any national law which relates to the use of such road.
- (4) A contract contemplated in subsection (1) shall be confidential and no party thereto may reveal to any other person any technical, price or other information relating to the contract without the consent of the other party or parties.
- (5) For the purpose of this section, an authorised person may only levy tolls and disburse toll revenue in accordance with the contract concluded with the Minister or the **toll roads agency** and provided that the Minister has determined the maximum amount in terms of section 7ter (1).
- (6) The Minister shall, for the purposes of this section, publish in the Gazette procurement guidelines which shall at least address -
- (a) modes of contracting for implementation in roads;
 - (b) procurement methods;
 - (c) negotiation of contracts; and
 - (d) post-implementation reviews.”

Isolation and Confinement of dogs:

3. Every owner of a dog or cat in a guard area shall isolate and confine his dog or cat so as to prevent it from escaping from such guard areas and such confinement and isolation shall remain in force until further notice.

Presentation of Dogs and Cats for Vaccination:

4. A person who owns a dog or cat and lives within the area specified in the schedule to this Notice shall present his pets for inoculation at the designated vaccination centre and on the time specified in the Second Schedule.

Offence and Penalty:

5. An owner of a dog or cat who fails to comply with regulation 3 and 4 commits an offence and is liable on conviction, to a fine not exceeding E300-00 and in default of payment, to imprisonment for a period not exceeding 3 months.

Destruction of Dogs and Cats in Rabies Guard Areas:

6. (1) A Government Veterinary Officer may destroy a dog or cat in any of the Rabies guard areas if in his opinion, the dog or cat has not been confined so as to prevent it from escaping from such guard areas.
(2) In pursuance of sub-regulation (1) a Government Veterinary Officer may ask for the assistance of the Royal Swaziland Police in carrying out the provision of that sub-regulation.
