LEGAL NOTICE NO. 17 OF 2007

THE INCOME TAX ORDER, 1975 (Order No. 21 of 1975)

INCOME TAX: DECLARATION OF SMALL BUSINESS TAXPAYERS AS PROVISONAL TAXPAYERS AND THE METHODS OF CALCULATING THEIR PROVISIONAL TAX

In exercise of the powers conferred by paragraph 1 of the Fourth Schedule to the Income Tax Order 1975, as amended, the Commissioner of Taxes hereby issues the following notice.

Citation and Commencement

1. This Notice may be cited as the declaration of small business taxpayers as provisional taxpayers and the methods of calculating their provisional tax notice 2007 and shall come into effect on 1 March 2007.

Declaration of small business taxpayers as provisional taxpayers

2. The Commissioner hereby declares that all small business taxpayers carrying on business or trade appearing in the schedule to this notice are provisional taxpayers in accordance with subparagraph (d) of the definition of "provisional taxpayer" as occurring under paragraph 1 of the Fourth Schedule.

Definition

3. In this notice, unless the context otherwise requires -

"gross turnover", in relation to a taxpayer who is ordinarily resident or carrying on business, in any year of assessment, means the amount shown in the accounts of the taxpayer as the gross proceeds derived in the carrying on of business or trade during the year of assessment including the gross proceeds arising from the disposal of trading stock, without the deduction for expenditure or losses incurred in deriving that amount,"

"small business taxpayer" means, unless the Commissioner in a particular case otherwise directs, any taxpayer who is ordinarily resident or carrying on business in Swaziland whose gross turnover derived from carrying on of that business or trade is less than five hundred thousand emalangeni in a year of assessment.

Method of calculating provisional tax

4. Subject to paragraph 5, where the gross turnover of a small business taxpayer ordinarily resident or carrying on business in Swaziland is less than five hundred thousand emalangeni the provisional tax payable by such taxpayer in any year of assessment shall be determined as follows -

A. Trade/Business

Turnover/Sales/ Gross Income
Less business expenses
Net Profit

xxxx

xxxx

The expenses including cost of sales to be deducted shall not exceed 75% of turnover/sales/ gross income.

B. Farming

The expenses including cost of sales to be deducted shall not exceed 75% of turnover/sales/gross income.

C. Rental Income

The expenses to be deducted shall not exceed 30% of gross rentals.

D. Vocation/Services/bottle stores/bars/taverns

Gross RevenuexxxxLess expensesxxxxNet Revenuexxxx

The expenses to be deducted shall not exceed 65% of gross revenues.

Persons excluded from this notice

5. Subparagraph 4 does not apply to a company as defined in section 2 of the Order.

Applicable tax rate

6. For the purposes of any calculation of normal tax under subparagraph 4, the rate at which such tax is to be calculated shall be 12 per cent in respect of any year of assessment.

Payment of provisional tax

- 7. A small business taxpayer is liable to pay two instalments of provisional tax, on or before the last day of December or June of the year of assessment, in respect of the taxpayer's liability for normal tax for that year of assessment.
- 8. For the purposes of subparagraph 7, the amount of each instalment of provisional tax for a year of assessment shall be calculated as follows -
 - (a) On or before 31 December, a first provisional tax payment equal to 50% of the total estimated tax; and
 - (b) On or before 30 June, a second provisional tax payment equal to the difference between 100% of the total estimated tax and the sum of the previous provisional tax payment.

Set-off of provisional tax against tax payable

9. Each payment of provisional tax shall be credited against the tax payable by the taxpayer in the year of assessment to which the payment relates.

Refunds

10. Where the total provisional tax credited under paragraph 9 exceeds the taxpayer's amount of tax payable for the tax year the excess shall be refunded to the taxpayer.

Recovery of provisional tax

11. Any payment of provisional tax, when it becomes due and payable, is a debt to the Government, and the provisions of this Order shall apply for the purposes of the collection and recovery of provisional tax by the Commissioner.

Furnishing of return of estimates

12. Every taxpayer to whom this notice applies shall furnish an estimate of the gross turnover of the taxpayer for each year of assessment and shall include with the estimate for a year of assessment, a statement of the actual gross turnover of the taxpayer for the previous year of assessment.

Prescribed returns

13. A taxpayer's estimate under paragraph 12 shall be in the form prescribed by the Commissioner and shall be furnished to the Commissioner by the due date for payment of the first provisional tax for the year of assessment.

Estimate to apply for the whole year of assessment

14. A taxpayer's estimate under paragraph 12 shall remain in force for the whole of the year of assessment unless the taxpayer furnishes a revised estimate to the Commissioner which revised estimate shall only apply to the calculation of the provisional tax payable by the taxpayer after the revised estimate was furnished to the Commissioner.

Failure to furnish estimate

15. Where a taxpayer fails to furnish an estimate of gross turnover as required by paragraph 12, the estimated gross turnover of the taxpayer for the year of assessment shall be such amount as estimated by the Commissioner.

Penalty on late payment of provisional tax

16. If any taxpayer fails to pay any amount of provisional tax for which he is liable within the period allowed for payment in terms of paragraph 7 he shall, in addition to any other penalty or charge incurred by him under the Order, pay to the Commissioner a penalty equal to twenty per cent of the amount not paid.

Offences

17. Any person who fails to submit to the Commissioner an estimate of his gross turnover as required under paragraph 12 shall be committing an offence and liable on conviction to a fine not exceeding one thousand emalangeni or to imprisonment for a period not exceeding twelve months, or both.
