#### THE APPROPRIATION BILL, 2007

#### (Bill No. 2 of 2007)

#### (To be presented by the Minister of Finance)

#### MEMORANDUM OF OBJECTS AND REASONS

The objects of this bill is to charge the Consolidated Fund with the sum of Eight billion, one hundred and sixty-eight million, eight hundred and nine thousand Emalangeni (8,168,809) for the period commencing on the 1<sup>st</sup> April, 2007 ending on the 31<sup>st</sup> March, 2008.

#### A BILL entitled

AN ACT to provide for the appropriation of a certain sum of money for the financial year commencing on the 1<sup>st</sup> April, 2007 and ending 31<sup>st</sup> March, 2008.

**ENACTED** by the King and the Parliament of Swaziland

#### Short title and Commencement

1. This Act may be cited as the Appropriation Act, 2007 and shall come into force on the 1<sup>st</sup> April, 2007.

#### Charge to Consolidated Fund •

2. The Consolidated Fund is charged with sum of money not exceeding in the aggregate Eight billion, one hundred and sixty-eight million, eight hundred and nine thousand Emalangeni (8,168,809) as required for the services of the Government of the Kingdom of Swaziland during the financial year commencing on the 1<sup>st</sup> April, 2007 and ending on the 31<sup>st</sup> March, 2008.

#### Application of sum appropriated

3. The sum appropriated by Section 2 shall be applied to the services set out in the first column of the Schedule and in the respective amounts appearing in the second and third columns in respect of each service.
