THE BUILDING ACT, 1968 (Act No. 34)

APPOINTMENT OF A LOCAL AUTHORITY FOR A CONTROLLED AREA (MHOBODLENI) NOTICE, 2007 (Under Section 2)

In exercise of the powers conferred by Section 2 of the Building Act, 1968, the Minister for Housing and Urban Development issues the following Notice -

Citation and Commencement

- 1. (1) This Notice may be cited as the Appointment of a Local Authority for a Controlled Area (Mhobodleni) Notice, 2007.
 - (2) This Notice shall come into force on the date of publication.

Appointment of a Local Authority

- 2. (1) Mr Paul Nkambule is appointed a Local Authority for Mhobodleni area, and in the due performance of the local authority duties and obligations he shall be assisted by the following persons -
 - (a) Gcokoma Dlamini
 - (b) Elinah Wamkoya
 - (c) Maria Ntjangase
 - (d) Stan Mabuza
 - (e) Michael Mntonzima Dlamini
 - (f) America Robinson
 - (g) David Mdluli
 - · (h) Nkwente Lukhele
 - (i) Phophonyane Maziya
 - (j) Bhekithemba Dlamini
 - (i) Tito Simelane

Local Authority to report to Minister

3. The Authority shall serve as a competent authority on behalf of the Ministry of Housing and Urban Development and shall report to the Minister.

Term of Office

- 4. (1) The Authority and the Assistants to the Authority shall hold office for a period of five years from the date of coming into force of this Notice.
- (2) A person appointed as an Assistant to the Authority may be removed by the Minister where the Assistant has
 - (a) been incapacitated by illness;
 - (b) failed to attend three consecutive meetings;
 - (c) failed to perform the duties of office to the satisfaction of the Authority;
 - (d) done any dishonest act: and
 - (e) resigned.
 - (3) The Minister may remove an Assistant for any resason the Minister deems just.

Existing Committee

5. All existing community committees, bandlancane, councils and development committees shall cease to exist.

Allowances

6. The Authority and the Assistants to the Authority shall be paid such allowances as are payable to Government Statutory Bodies as the Minister of Finance may from time to time determine.

In exercise of the powers conferred by Section 4 of the Building Act, 1968, the Minister for Housing and Urban Development issues the following Notice -


Citation and Commencement
