MEMORANDUM OF OBJECTS AND REASONS

The object of this Bill is to charge the Consolidated Fund with the sum of Nine billion, sixty-nine million, seven hundred and forty-three thousand Emalangeni (9,069,743) for the period commencing on the 1st April, 2008 ending on the 31st March, 2009.

A BILL entitled

AN ACT to provide for the appropriation of a certain sum of money for the financial year commencing on the 1st April, 2008 and ending 31st March, 2009.

ENACTED by the King and the Parliament of Swaziland.

Short title and commencement

1. This Act may be cited as the Appropriation Act, 2008 and shall come into force on the 1st April, 2008.

Charge to Consolidated Fund

2. The Consolidated Fund is charged with sum of money not exceeding in the aggregate Nine billion, sixty-nine million, seven hundred and forty-three thousand Emalangeni (9,069,743) as required for the services of the Government of the Kingdom of Swaziland during the financial year commencing on the 1st April, 2008 and ending on the 31st March, 2009.

Application of sum appropriated

3. The sum appropriated by Section 2 shall be applied to the services set out in the second column of the Schedule and in the respective amounts appearing in the third and fourth columns in respect of each service.
