LEGAL NOTICE NO. 57 OF 2008

URBAN GOVERNMENT ACT, 1969
(Act No. 8 of 1969)

THE APPOINTMENT OF A COMMISSION OF ENQUIRY INTO THE
INTENT TO EXTEND URBAN BOUNDARIES FOR MATSAPHA,
MBABANE AND NGWENYA NOTICE, 2008
(Under section 4)

In exercise of the powers conferred by Section 4 of the Urban Government Act, 1969 the Minister for Housing and Urban Development hereby issues the following Notice -

Citation and Commencement

1. This Notice may be cited as the Commission of Enquiry into the Intent to extend urban boundaries for Matsapha, Mbabane and Ngwenya Notice, 2008' and shall come into force on the 17th March, 2008.

Establishment and Composition of the Commission

2. (1) There is established a Commission to be known as the Commission of Enquiry into the intent to extend urban boundaries for Matsapha, Mbabane and Ngwenya (hereinafter referred to as the Commission).

(2) The Commission shall be composed of the following members -

Mabandla Manzini	-	Chairman
Precious Dlamini	-	Member
John Resting	-	Member
Mandla Mlapha	-	Member
Cyril Broadwell	-	Member
Stephen Khumalo	-	Secretary

Functions and Terms of Reference of the Commission

3. (1) The Commission shall consider any representations made in response to the notification on intent to extend urban boundaries for Matsapha, Mbabane and Ngwenya.

(2) The Commission shall advise the Minister whether or not the intended notice to extend urban boundaries for Matsapha, Mbabane and Ngwenya should be published.

Quorum

4. The quorum of the Commission shall be three members.

Venue and Address of the Commission

5. (a) The address of the Commission shall be Box 1832, Mbabane.

(b) The Chairman shall determine the Venue for the enquiry and the public shall be informed thereon.

Duration of Commission and Submission of Report

6. (1) The Commission shall submit a final report on or before the 30th day of May 2008.
- (2) The report shall comprise -
 - (a) a detailed report on the inquiry process and findings; and
 - (b) a recommendation of a proposed course of action on all issues raised.

Allowances

7. The Commissioners shall be entitled to such allowances and, where applicable, reimbursement for traveling expenses in accordance with Finance Regulations and Circulars that may from time to time be implemented or as the Minister may sometimes determine.

Extension of time

8. The Minister may, in consultation with the Commissioners, extend the duration of the commission and submission of the report.

LEGAL NOTICE NO. 58 OF 2008

URBAN GOVERNMENT ACT, 1969
(Act No.8 of 1969)

THE APPOINTMENT OF LOCAL AUTHORITY INSPECTOR FOR THE
MUNICIPAL COUNCIL OF MANZINI NOTICE, 2008
(Under Section 105)

In exercise of the powers conferred by Section 105 of the Urban Government Act, 1969 the Minister for Housing and Urban Development issues the following Notice -

Citation and Commencement

1. (1) This Notice may be cited as The Appointment of Local Authority Inspectors for the Municipal Council of Manzini Notice, 2008 and shall be deemed to have come into force on the 1st April 2008.

Appointment of Inspector

2. (1) Mr. Stephen Thembinkosi Motsa is appointed a Local Authority Inspector for the Municipal Council of Manzini.

Powers and Duties of the Inspectors

3. The Inspectors shall -
- (a) Investigate compliance with internal procedures when creating the post of Financial Accountant;
 - (b) To investigate compliance with internal procedures when filling the post of Financial Accountant including any acting appointments against this position.
 - (c) Determine if there is any pecuniary interest by any person in relation to the filling of this post; and
 - (d) Investigate any other matter incidental thereto.

Submission of Report

4. (1) The Inspector shall submit a final report within a period not exceeding seven (7) working days from date of appointment.

(2) The report shall comprise -

- (a) the method of enquiry by the Inspectors; and
- (b) detailed findings and recommendations based on the terms of reference.

Allowances

5. The Inspector shall be entitled to such allowances and, where applicable, reimbursement for traveling expenses in accordance with Finance Regulations and Circulars that may from time to time be implemented or as the Minister may sometimes determine.

Extension of Inspection

6. The Minister may, in consultation with the Inspector, extend the time of inspection and submission of report.
