LEGAL NOTICE NO. 108 OF 2008

THE CONSTITUTION OF SWAZILAND ACT, 2005 (Act No. 1 of 2005)

THE PRESCRIPTION OF STATUTORY SALARIES AND ALLOWANCES OF COMMISSIONS AND BOARDS NOTICE, 2008 (Under Section 208)

In exercise of the powers contained in Section 208 of the Constitution of Swaziland Act, 2005, I hereby issue the following Notice -

Citation and Commencement

1. This Notice may be cited as the Prescription of Statutory Salaries and Allowances Notice, 2008, and shall be deemed to have come into force on the 1st day of April, 2008.

Prescription of salaries and allowances

2. Without prejudice to any other benefits conferred by any other law, the holder of an office specified in the first column of the Schedule shall, be paid not less than the salary or allowance, or both (as the case may be), specified in relation to the holder, in the second, third, fourth, fifth, sixth, seventh and eighth columns of the Schedule.
