

**THE COMMISSIONS OF ENQUIRY ACT, 1963  
(Act No. 35 of 1963)**

**THE APPOINTMENT OF THE KING'S CUP GOLF TOURNAMENT  
TASK TEAM NOTICE, 2008  
(Under Section 3)**

In exercise of the powers conferred by Section 3 and 5 of the Commissions of Enquiry Act, 1963, the Minister for Tourism, Environment and Communications issues the following notice.

***Citation and Commencement***

1. This Notice may be cited as the Appointment of the King's Cup Golf Tournament Task Team and shall be deemed to have come into force on April 1, 2008.

***Establishment and appointment of members of the Task Team***

2. (1) There is hereby established a committee to be known as the King's Cup Golf Tournament Task Team (hereinafter referred to as "the Task Team") to operate for a period not exceeding 30<sup>th</sup> March 2009.

(2) The Task Team shall be composed of the following member -

- (a) Gcebile Dlamini, Ministry of Tourism - Chairperson;
- (b) Eric Maseko, Swaziland Tourism Authority or representative - Member;
- (c) Samuel Richards - Member;
- (d) Philisiwe Dlamini, Nedbank - Member;
- (e) Khulile Dlamini, MTN or representative - Member;
- (f) Musa Mdluli, Ministry of Tourism - Member;
- (g) Musa Dlamini, Ministry of Tourism - Member;
- (h) Phumelela Shongwe, SPTC or representative - Member;
- (i) Dan Zikalala - Member; and
- (j) Hermon Motsa, Ministry of Tourism - Secretary.

(3) The quorum of the Task Team shall be five members including the Chairperson.

***Functions of the Task Team***

3. The Task Team shall -

- (a) overall management the King's Cup Golf tournament 2008;
- (b) scout for funding and sponsorship of the event;

- (c) organize dates and venue for the event in consultation with the relevant stakeholders;
- (d) co-opt expertise where necessary;
- (e) liaise with other local or foreign professional and amateur golfers associations on the logistics of the King's Cup; and
- (f) report to the Honourable Minister for Tourism.

***Meetings***

4. The Task Team shall meet at the Ministry of Tourism, Environment and Communications or such other place and times as the Chairperson may determine.

***Submission of report***

5. (1) The Task Team shall give progress reports on the preparations of the 2008 event and shall be made to the minister periodically.

(2) The Task Team shall present its final report of the event to the Minister before the 30<sup>th</sup> November, 2008 or on such date as the Minister may determine.

***Remuneration of the members of the Task Team***

6. The members of the Task Team shall be paid sitting allowances in accordance with Government Finance Circular No. 2 of 2005.
