LEGAL NOTICE NO. 27 OF 2011

THE DAIRY ACT, 1968 (Act No. 28 of 1968)

LEVY ON MILK AND DAIRY PRODUCTS REGULATIONS, NOTICE 2011 (Under Section 25)

In exercise of the powers conferred by Section 25 of the Dairy Act 1968, the Minister of Agriculture, on recommendation of the Swaziland Dairy Board, hereby make the following regulations:

Citation and Commencement

1. These Regulations may be cited as the Levy on Milk and Dairy Products Regulations, 2011 and shall be deemed to have come into effect on the 1st January 2011.

Levy to be paid by Importers of Milk and Dairy Products.

2. All importers of Milk and Dairy Products shall pay a levy on all imported dairy products listed on the schedule based on the percentage of the invoice value.

Levy to be paid by Manufacturers of Dairy Products

3. All manufacturers of Dairy Products shall pay a levy on all listed imported scheduled dairy products for manufacturing based on the percentage of the invoice value.

4. All imports of dairy products shall be supported by the necessary dairy import permit issued in terms of the Dairy Act of 1968, Veterinary Import Permit and Veterinary Health Certificate issued in terms of Animal Disease Act of 1965, Invoices and Swaziland Trading Licence issued in terms of the Trading Licence Order of 1975.

Revocation of Legal Notice No. 80 of 2006

5. Legal Notice No. 80 of 2006 is hereby revoked.
