#### MANZINI PUBLIC SERVICE VEHICLES BYE LAW, 1970 (Under Bye Law 3)

#### DETERMINATION OF ROUTES, STOPPING PLACES OR STANDS FOR PUBLIC VEHICLES WITHIN THE MANZINI CITY BOUNDERIES, NOTICE 2011 (Under Bye Law 3)

In exercise of the powers conferred by Bye-Law 3, the Manzini Municipal Council hereby issues the following Notice -

#### Citation and Commencement

1. (1) This Notice may be cited as the Determination Routes, Stopping Places or Stands for Public Vehicles within the Manzini City Boundaries Notice, 2011.

(2) This Notice shall come into force on the 1<sup>st</sup> July, 2011.

#### Routes, stopping places or stands for public transport.

3. All public vehicles within the City Boundaries shall use the routes and stops or stands as detailed in the attached schedule.


#### SCHEDULE TO THE MANZINI PUBLIC SERVICE VEHICLE BYE LAW 3, 1970

Schedule of routes, stopping or stands for public vehicles within the Manzini City

•	East Bound Kombies -	•	These will enter the city via MR3, Nkoseluhlaza Street, Masalesikhundleni, Mancishane Street, into the Satellite Bus Rank. Exit would be via Tenbergen Street, Masalesikhundleni, Kelly, Tikhuba and MR3 east (Siteki Road).
•	East Bound Buses -		These will enter the city via MR3, Nkoseluhlaza Street, Masalesikhundleni, Mancishane Street, into the Satellite Bus Rank. Exit would be via Tenbergen Street, Masalesikhundleni, Kelly, Tikhuba and MR3 east (Siteki Road).
•	West Bound Kombies -		These will enter and exit the Main Bus Rank via MR3 / Dr. Hynd Road, Central Distributor Road and Mentjies Street.
	West Bound Buses -		These will enter the city via MR3 and Ngwane Street into the Main Bus Rank. Exit will be via Mentjies Street, Central Distributor and MR3 / Dr. Hynd Road.

- There will be a **Shuttle Service** moving passengers between the Main Bus Rank and the Satelite Bus Rank under terms and conditions to be negotiated with the transport operators.
- Stopping Places for passenger boarding and alighting would be as shown in the attached map.


#### MAIN BUS RANK ROUTE

#### SATELLITE BUS RANK ROUTE


