DEPARTED ASIANS' PROPERTY CUSTODIAN BOARD DECREE No. 27 OF 1973.

NOTICE.

ALL PERSONS WHO LEFT PROPERTIES IN UGANDA DURING THE 1972 ASIAN EXODUS.

All persons who left their immovable properties in Uganda during the 1972 Asian exodus are reminded that the Government of Uganda is still receiving and processing applications for repossession. These are under two categories:—

1. Those from persons who were citizens of Uganda in 1972 (including Limited Liability Companies and Trusts) which are not subject to the provisions of the Expropriated Properties Act of 1982.

2. Those from persons who were not citizens of Uganda in 1972 and were consequentially expelled under the Immigration (cancellation of entry permits and Certificates of Residences) Decree, 1972. Although these persons were, under the Expropriated Properties Act of 1982, given 90 days within which to apply for the repossession of their properties, the Minister responsible for Finance is, in his discretion provided under the Act, still accepting and handling these applications. Persons who had applied for compensation are encouraged to come and take physical possession of their properties.

TAKE NOTICE that the Minister responsible for Finance shall continue to receive and handle both categories of applications up to the 30th day of October, 1993. After the 30th day of October, 1993 no application shall be accepted and all properties that shall not have been claimed by that date shall be deemed abandoned by their owners, and the Minister shall proceed to make the appropriate orders in conformity with section 8 of the Expropriated Properties Act of 1982.
