THE UGANDA NATIONAL BUREAU OF STANDARDS ACT, 1983.

(Act No. 1 of 1983, Section 18).

#### PRELIMINARY NOTICE.

IN ACCORDANCE with section 17 of the Uganda National Bureau of Standards (UNBS) Act, 1983, the National Standards Council intends to recommend to the Minister for Tourism, Trade and Industry to declare the Standard Specifications indicated below for compulsory application after 60 days from the date of this notice.

The National Standards Council therefore calls upon all interested persons or parties likely to be affected by compulsory application of these standards to lodge their objections in writing within 21 days from the date of this notice to the Executive Director, Uganda National Bureau of Standards, P.O. Box 6329, Kampala.

Every person who has an objection to the declaration of a standard as compulsory shall be entitled to be heard by council. No standard specification shall be declared compulsory until all persons who have lodged objections have been heard by the council.

#### **Specifications**

1. Jam (fruit preserves) and Jellies - No. US 31:1999

#### Scope:

The standard applies to a class of fruit spreads commonly known as jams and jellies and which are prepared from single fruits or from two or more fruits.

2. Citrus Marmalade - No. US 32:1999

#### Scope:

The standard applies to Marmalade prepared from citrus fruit.

3. Tomato Sauce - No. US 39:1999

#### Scope:

The standard prescribes the quality requirements for tomato-sauce. It does not cover tomato ketchup and tomato concentrate, which are covered by other standards.

4. Tomato Ketchup - No. US 38:1999

#### Scope:

The standard prescribes the quality requirements for tomato ketchup. It does not cover tomato sauce and tomato concentrate, which are covered by other standards.

5. Bottled/Packaged Waters Other than Natural Mineral Waters - No. US 42:1999

#### Scope:

The standard applies to all waters that are filled into containers of various compositions, forms, and capacities that is suitable for direct human consumption without necessary further treatment. These waters may be used as ingredients in beverages (e.g. diluted juices, flavoured bottled waters).

6. Bottled/Packaged Natural Mineral Waters - No. US 43:1999

#### Scope:

The standard specifies the requirements and methods of test for bottled/packaged natural mineral waters offered for human consumption. It does not apply to natural waters sold or used for other purposes.

7. Gins - No. US 44:1999

#### Scope:

This standard specifies the requirements and methods of sampling for Gins.

8. Carbonated and Non Carbonated Soft Drinks - No. US 47:1999

#### Scope:

This Uganda standard prescribes the requirement and methods of test for both Carbonated and Noncarbonated soft drinks.

9. Code of Practice for the handling, Processing, Storage, and Placing on the Market of Fish and Fishery Products - No. US 129:1999/EAS 62

#### Scope:

This code of practice for the handling, processing, storage, and placing on the market of fish and fishery products lays down the health conditions for the production and placing on the market of fish and fishery products for human consumption.

 Uganda Standard specification for Edible Salt - No. US 203:1999

#### Scope:

This standard specifies requirements and methods of sampling and test methods for edible salts.

Note: This standard cancels and replaces Uganda Standard US 203:1993, which has been revised.

11. Standard specification for hexagonal weights, ordinary accuracy class from 100 gm to 50 kg. - No. US 1000:1999/ ARS 563

#### Scope:

This standard specifies the denominations and requirements of cast iron hexagonal weights of ordinary accuracy class.

12. Standard specification for material measures of length - No. US 1001: 1999/ ARS 294

#### Scope:

This standard applies to material measures of length of three accuracy classes, for general use. The standard specifies the technical, metrological, and administrative conditions which are mandatory for these measures.

13. Standard specification for Tyre pressure gauges for motor vehicles - No. US 1002:1999/ OIML R23

#### Scope:

This Uganda Standard lays down the principle metrological (measurement) characteristics to which pressure gauges intended for the measurement of the inflation pressures in motor-vehicle tyres shall conform.

 Standard specification for weights of classes E1, E2, F1, F2, M1, M2, M3 - No. US 1003: 1999/ OIML R111

#### Scope

This standard contains the principle physical characteristics and metrological requirements for weights which are used for the verification of weighing instruments for the verification of weights of a lower class accuracy with weighing instruments.

15. Standard specification for measuring systems for liquids other than water - No. US 1005:1999/ OIML R 117

#### Scope:

This standard specifies the metrological and technical requirements applicable to dynamic measuring systems for quantities of liquids other than water subject to legal controls. It also provides requirements for the approval of parts of the measuring systems (meter, etc.).

16. Standard atmospheres for conditioning and/or testing specifications - No. US 1011:1999/ ARS 21

#### Scope:

This standard lays down three standard atmospheres for conditioning and/or testing which are not very different from ordinary ambient conditions. 17. Cylindrical weights of medium accuracy class (M2) from 1 gram to 10 kilograms - No. US 1013:1999/ARS 304

#### Scope:

This standard applies to cylindrical weights of medium accuracy class (Class M2) in the range of 1 g to 10 kg.

5. Bottled/Packaged Waters Other than Nature's Mineral Waters - No. US 42:1999

#### Scope

The standard applies to all waters that are filled into containers of various compositions, forms, and capacities that is suitable for direct human consumption without necessary further treatment. These waters may be used as ingredients in beverages (e.g. diluted juices, flavoured bottled waters).

 Bottled/Packaged Natural Mineral Waters - No. US 43:1999

#### Scope:

The standard specifies the requirements and methods of test for bottled/packaged natural mineral waters offered for human consumption. It does not apply to natural waters sold or used for other purposes.

7. Gins - No. US 44:1999

## Scope:

This standard specifies the requirements and methods of sampling for Gins.

8. Carbonated and Non Carbonated Soft Drinks - No. US 47:1999

#### Scope:

This Uganda standard prescribes the requirement and methods of test for both Carbonated and Noncarbonated soft drinks.

9. Code of Practice for the Handling, Processing, Storage, and Placing on the Market of Fish and Fishery Products - No. US 129:1999/EAS 62

#### Scope:

This code of practice for the handling, processing, storage, and placing on the market of fish and fishery products lays down the health conditions for the production and placing on the market of fish and fishery products for human consumption.

10. General requirements for establishing a Hazard Analysis Critical Control Points (HACCP)— Programme for Food Processing Establishments No. US 130:1999

#### Scope:

This Uganda standard lays down the basic requirements for implementing the requirements for Hazard Analysis Critical Control Programme for a food processing establishment so as to ensure safe production of products.

11. Fish and fishery products - Determination of the concentration of volatile nitrogenous bases (TVB-N) No. US 131:1999

#### Scope:

This method describes a reference procedure for identifying the Nitrogen concentration of volatile nitrogenous bases (Total-Volatile Base-N: TVB-N) in fish and fish products.

Section C: Environment Management System Standards

1. Environment Management Systems - Specification with guidance for use - No. US 87:1999/ISO 14001

#### Scope:

This international standard provides guidance on the development and implementation of environmental management systems and principles, and their coordination with other management systems.

#### Scope:

This international standard provides the general principles of environmental auditing that are applicable to all types of environmental audits. Any activity defined as an environmental audit in accordance with this International Standard should satisfy the recommendations given in it.

4. Guidelines for environmental auditing-Audit procedures-Auditing of Environmental management systems - No. US 90:1999/ ISO 14011

#### Scope:

This international standard establishes audit procedures that provide for the planning and conduct of an audit of EMS to determine conformance with EMS audit criteria.

 Guidelines for environmental auditing-Qualification criteria for environmental auditors - No. US 91:1999/ ISO 14012

#### Scope:

This international standard provides guidance on qualification criteria for environmental auditors and lead auditors and is applicable to both internal and external auditors. Criteria for selection and composition of audit teams are not included, reference is made to US 90:1999/ISO 14011.

6. Environmental and declarations - Genera principles. US 92:1999/ ISO 14020

#### Scone

This international standard establishes guiding principles for the development and use of environmental labels and declarations.

7. Environmental labels and declarations-Type 1: Auditing - Environmental labelling- Principles and procedures - No. US 93:1999/ ISO 14024

#### Scope:

This international standard establishes the principles and procedures for developing Type I environmental labelling programmes, including the selection of product categories, product function characteristics; and for assessing and demonstrating compliance. This international standard also establishes the certification procedures for awarding the label.

8. Environment management -Life Cycle Assessment - Goal and scope definition and inventory analysis. No. US 94:1999/ ISO 14041

#### Scope:

This international standard in addition to ISO 14040 specifies the requirements and procedures necessary for the compilation and preparation of the definition of goal and scope for a Life Cycle Assessment (LCA), and for performing, interpreting and reporting a Life Cycle Inventory analysis (LCI).

9. Environment Management - Vocabulary. No. U 95:1999/ ISO 14050

#### Scope:

This standard contains definitions of fundamental concepts related to environmental management.

10. Environmental labels and declarations -Self-declared environmental claims (Type environmental labelling) - No. US 134 ISO 14021

#### Scope

This international standard specifies requirements for self declared environmental claims, including statements symbols, graphics, regarding products. It further describes selected terms commonly used in environmental claims and gives qualifications their use. This international standard also describes a general evaluation and verification methodology for self declared environmental claims and specific evaluation and verification methods for the selected claim in this standard.

Section D: Quality Management System Standards

1. Quality Management and Quality Assurance Standards-Part 1:Guidelines for selection and use-No. US 117:1999/ ISO 9000-1

## Scope:

This part of ISO 9000 clarifies principal quality-related concepts and the distinctions and interrelationships among them provides guidance for the selection and use of the ISO 9000 family of international standards on quality management and quality assurance.

 Quality Management and Quality Assurance Standards-Part 2:Generic guidelines for application of ISO 9001, 9002, and 9003 - No. US 118:1999/ ISO 9000-2

#### Scope:

This part of ISO 9000 gives guidance on the application of the 1994 versions of ISO 9001, ISO 9002 and ISO 9003.

3. Quality Management and Quality Assurance Standards-Part 3: Guidelines for application of ISO 9001 to the development, supply, installation and maintenance of computer software - No. US 119:1999/ ISO 9000-3

#### Scope:

This part of ISO 9000 sets out guidelines to facilitate the application of ISO 9001: 1994, for organisations developing, supplying, installing and maintaining computer software. It does not add to, or otherwise change, the requirements of ISO 9001.

4. Quality Systems -Model for Quality Assurance in Design, Development, Production, Installation and Servicing - No. US 120:1999/ ISO 9001

#### Scope:

This international standard specifies quality system requirements for use where a supplier's capability to design and supply conforming product needs to be demonstrated.

The requirements specified are aimed primarily at achieving customer satisfaction by preventing non-conformity at all stages from design through to servicing.

 Quality Systems -Model for Quality Assurance in Production, Installation and Servicing - No. 121:1999/ ISO 9002 Scope:

This international standard specifies quality system requirements for use where a supplier's capability to supply conforming product to an established design needs to be demonstrated.

The requirements specified are aimed primarily at achieving customer satisfaction by preventing non-conformity at all stages from design through to servicing.

Quality Systems - Model for quality assurance in final inspection and test - No. US122: 1999/ ISO 9003

Scope:

This international standard specifies quality system requirements for use where a supplier's capability to detect and control the disposition of any product non conformity and test needs to be demonstrated.

It is applicable in situations when the conformance of product to specified requirements can be shown with adequate confidence providing that certain suppliers' capabilities for inspection and tests conducted on finished products can be satisfactorily demonstrated.

Quality Management and Quality System Elements -Part 1: guidelines - No. US 123:1999/ ISO 9004-1

Scope:

This standard provides guidance on quality management and quality system elements. The quality system elements are suitable for use in the development and implementation of a comprehensive and effective in-house quality system, with a view to ensuring customer satisfaction.

Quality Management and Quality System Elements-Part 2:Guidelines for services - No. US 124:1999/ ISO 9004-2

Scope:

This standard gives guidance for establishing and implementing a quality system within an organisation. It is based on the generic principles of internal quality management described in ISO 9001:1987 and provides a comprehensive overview of a quality system specifically for services.

Quality Management and Quality Assurance-vocabulary - No. US 125:1999/ ISO 8402

Scope

This standard defines the fundamental terms relating to quality concepts, as they apply to all areas, for the preparation and use of quality-related standards and for mutual understanding of international communication.

Guidelines for Auditing Quality Systems-Part 1: Auditing - No. US 135:1999 ISO 10011-1

Scope:

This standard establishes basic audit principles, criteria and principles, and provides guidelines for establishing, planning, carrying out, and documenting audits of quality systems.

Guidelines for Auditing Quality Systems -Part 2: Qualification Criteria for Quality System Auditors -- No. US 136:1999/ ISO 10011-2

-Scope:

-This standard gives the qualification criteria for auditors.

 SI Units and recommendations for the use of their multiples and of Certain Other units - No. US 1006:1999/ ARS 1

#### Scope

This standard describes the International System of Units, recommends selected decimal multiples and sub multiples of the SI units for general use -gives certain other units which may be used with the International System of units and -defines base and supplementary SI units.

8. General principle concerning quantities, units and symbols - No. US 1007:1999/ ARS 2/0

#### Scope:

The standard gives general information about principles concerning physical quantities, equations, quantity and unit symbols, and coherent unit systems, especially the International System of Units, SI.

This standard specifies series of preferred numbers.
