APPOINTMENT OF CUSTOMS AREAS.

NOTICE.

1. TAKE NOTICE THAT under section 9 of the East African Customs and Transfer Tax Management Act (Rev. 1970) the Commissioner General of Uganda Revenue Authority hereby appoints the places specified in the Second Schedule to this Notice as Customs Areas for purposes of the Customs Laws.

2. This Notice may be cited as the Customs (Appointment of Customs Areas) Notice, 1999.

3. The appointed areas shall be used as Inland Container Depots and shall be referred to as such (i.e. ICD).

4. The Inland Container Depots appointed are subject to conditions specified in the First Schedule to this Notice.

FIRST SCHEDULE.

GENERAL REQUIREMENTS OF AN INLAND CONTAINER DEPOT (ICD)

- Perimeter Wall.
- Razor Wire on Perimeter.
- Suitable office accommodation for Uganda Revenue Authority staff.
- A suitable barrier gate to monitor traffic to and from the Depot.
- Clearly demarcated Customs area specifying various types of clearance procedures.
- Proper security and lighting including provision of guards.
- Verification shed and bay.
- Warehouse or transit shed for deposit of goods subject to Customs Control including detained or seized goods.
- A Customs Bond Security guaranteed by a reputable and licenced Insurance Company for purposes of securing taxes on goods in the ICD before taxes are paid and to ensure compliance with customs procedures.
