The divestiture was implemented as follows:-

- The Divestiture and Reform Implemention Committee (DRIC) at its 212th meeting held on November, 1st, 1998 decided that Uganda Clays Ltd. be divested by sale of 50,000 shares of Uganda Clays Ltd. shares to employees of Uganda Clays Ltd. under an ESOP scheme and the remaining shares be offered to the public through the stock exchange.
- DRIC also decided at the aforesaid meeting that the employees pay for their shares over a period of one year.
- Following an Initial Public Offering (IPO), a total 325,000 shares were offered at Shs. 4.000 per share to the public and employees on Uganda Securities Exchange and have been fully subscribed.
- In accordance with the Capital Markets Authority Statute 1996, the Companies Act and Rules and Regulations of the Uganda Securities Exchange, title to the shares has been transferred to the applicants following the successful IPO.
- 77,500 shares that are still to be paid for by employees will be held by the Minister of Finance, Planning and Economic Development and transferred to the employees as and when they pay for them in accordance with the ESOP terms.
