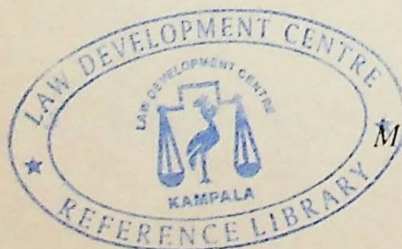
1. This Order may be cited as the External Trade (Importation Licence) (No. 6) Order, 2001. Citation.

2. (1) The person listed in column 1 of the Schedule is granted exclusive licence to import used tyres of different sizes, in the quantities listed in column 2 of the Schedule. Grant of exclusive licence.

(2) The exclusive licence referred to in sub-paragraph (1) shall be valid for one year only and if the licence expires before a person has imported the number of used tyres authorised by the licence, that person shall forfeit the balance of the tyres not imported.
