

# The Traffic and Road Safety (Speed of Motor Vehicle) (Exemption) (No. 6) Order, 2001.

# (Under section 176 of the Traffic and Road Safety Act, 1998)

IN EXERCISE of the powers conferred upon the Minister responsible for works, housing and communications by section 176 of the Traffic and Road Safety Act, 1998, this Order is made this 29th day of June, 2001.

Act 15 of 1998.

1. This Order may be cited as the Traffic and Road Safety Citation. (Speed of Motor Vehicle) (Exemption) (No. 6) Order, 2001.

2. A person who drives a motor vehicle and who competes Exemption. in the three days rally competition organised by Federation of Motor Sports Clubs of Uganda (FMU) and described as the Shell elix Rally, 2001, commencing on Friday 6th July, 2001 and ending on Sunday 8th July, 2001 is exempted from the provisions of subections (1) and (2) of section 121 of the Act for the duration of that rally.
