IN EXERCISE of the powers conferred upon the Minister by section 176(2) of the Local Governments Act, 1997 this Act No. 1 of 1997. Instrument is made this 29th day of June, 2001.

1. This Instrument may be cited as the Local Governments Citation. (Amendment of Schedules) Instrument, 2001.

2. The First Schedule to the Act is amended—

- (a) in Regulation 1 by inserting after "Local Governments" the words "Speaker and Deputy Speaker";
- (b) in Regulation 2(3) by replacing "2(i)(a)" with "2(1)(a)";

(c) in Regulation 3-

 (i) by inserting immediately after "Speaker" whenever it occurs, the words "Deputy Speaker";

- (ii) in sub-regulation (3) by replacing "3(i)" with "3(1)";
- (d) by replacing Regulation 4 with the following regulation-
