1. That I am a female adult Uganda citizen of sound mind.
2. That I was born in Koch, Gulu District and presently reside at 104 Henker Road, Stratford, London.
3. That in 1980, I lawfully married Mr. John Otto at the Registrar's Office in the District of Kampala in Uganda, and that:
 - (a) the said marriage was solemnised under the provisions of the Marriage Act in force in Uganda.
 - (b) after the said marriage, I lived and cohabited with the said John Otto at Kampala and there are children of the said marriage, to wit:
 - (i) Linda Anena born on 9th November, 1979;
 - (ii) Brian Acire born on 15th August 1982;
 - (iii) Viola Oyella born on 16th December, 1983.
4. That in 1986 the said John Otto abandoned the family and left the Country.
