The Movement (Elections) (Amendment) Regulations, 2001.

(Under section 38 of the Movement Act, 1997, Act 7 of 1997).

IN EXERCISE of the powers conferred upon the Minister by section 38 of the Movement Act, 1997, these Regulations are made this 3rd day of December, 2001.

1. These Regulations may be cited as the Movement (Elections) (Amendment) Regulations, 2001. Citation.

2. The Movement (Elections) Regulations, 1997 are amended by inserting immediately after regulation 9 the following new regulation— Amendment of S.I 57 of 1997.

"Filling of vacancies.

9A. Where the office of a chairperson of a movement committee becomes vacant, the secretary of that committee shall within thirty days after the occurrence of the vacancy notify the Secretariat in writing of the vacancy and the Secretariat shall as soon as possible notify the Electoral Commission of the vacancy to enable the Electoral Commission to conduct an election to fill the vacancy."
