POLICY DIRECTIVE

(This Policy Directive is issued in accordance with Section 18 of the Electricity Act, No. 9 of 1999).

IN EXERCISE of the functions and duties conferred on the Minister responsible for Electricity by Section 18 of the Electricity Act, 2000, this Policy Directive is issued to the Electricity Regulatory Authority this 19th day of December. 2001.

- 1. Whereas it is possible for a person other than the Uganda Electricity Board or the Uganda Electricity Transmission Company (UETC) to finance and construct transmission lines.
- 2. Whereas under a Power Purchase Agreement ("PPA") signed on the 8th December, 1999 between AES Nile Power Limited ("the Company") and Uganda Electricity Board it was agreed that the Company was to procure the finance and construct a transmission line and associated transmission facilities (known under the PPA as the "UEB Line") as part of the Bujagali Falls Hydroelectric Power Project.
- 3. Whereas the costs for the construction of the UEB line may be met in several ways including through the tariff and rate charges, approved by the Electricity Regulatory Authority chargeable by the transmission or distribution companies.
- 4. Whereas Government acknowledges that including the construction costs of the UEB line as a component of the rates and tariff charges, chargeable by the transmission and distribution companies, may result in a double charge to electricity consumers in Uganda.

Now THEREFORE, the Minister hereby directs the Electricity Regulatory Authority that in exercise of its functions under sections 11(f) and (g) of the Electricity Act, the Electricity Regulatory Authority should not allow any costs associated with the construction of the UEB line to be part of the transmission costs included within the rates of charges or tariff of any transmission or distribution Company.
