**The Public Service Commission (Amendment) Regulations, 2002.**

*(Under article 251 of the Constitution and section 22 of the Public Service Act, 1969, Act No. 22 of 1969).*

IN EXERCISE of the powers conferred upon the Public Service Commission by article 251 of the Constitution and section 22 of the Public Service Act, 1969, these Regulations are made this 28th day of December, 2001.

1. (1) These Regulations may be cited as the Public Service Commission (Amendment) Regulations, 2002 and shall be read as one with the Public Service Commission Regulations, in these Regulations referred to as the "principal Regulations".

(2) These Regulations shall be deemed to have come into force on the 8th day of October, 1995.

2. Regulation 43 of the principal Regulations is amended by substituting for subregulation (3) the following new subregulation—

"(3) If, upon consideration of the responsible officer's report, the Commission is of the opinion that proceedings for the dismissal of the officer should be continued, it may appoint a committee, which shall consist of not less than three members who shall be public officers, to inquire into the matter. One member



of the committee shall be a judge, magistrate or a public officer with legal qualifications, and all members shall be selected with due regard to the standing of the officer concerned. Neither the responsible officer nor any officer serving in the accused officer's Ministry or department shall be a member of the committee."

3. Regulation 44 of the principal Regulations is amended by substituting for subregulation (4)(a) the following—

"(a) the Commission may appoint a public officer to inquire into the matter;"

4. Regulation 45 of the principal Regulations is amended by substituting for subregulation (1) the following new subregulation—

"(1) Notwithstanding the provisions of regulation 43 of these Regulations, if a responsible officer considers that a person to whom this Part of these Regulations applied should be retired in the public interest on the grounds of public interest, the responsible officer—

(a) may obtain from the responsible officers of every Ministry or department in which the officer has served, reports as to his work and conduct; and

(b) shall, where reports are obtained under paragraph (a), allow the officer an opportunity of considering such reports and of showing cause why he should not be retired from the public service."
