5. That I on 1st day of March 2000, I changed my name to Nsajja David Livingstone, and I executed a Deed of Poll to that effect which was duly advertised in the "Bukedde" and from that date all my official documents and other transactions bear the new name.
6. That the change was not necessitated by fraud or force of will, but was in good faith.
7. That I now swear this affidavit to confirm that I have absolutely renounced my former names of Busajja David Livingstone, which do appear on my Leave Certificates and now have acquired the names of Nsajja David Livingstone by which I shall henceforth be known.
8. That whatever I have stated herein is true and correct to the best of my personal knowledge and belief.
