

(Under section 175 of the Traffic and Road Safety Act, Cap. 361).

IN EXERCISE of the powers conferred upon the Minister responsible for works, housing and communications by section 175 of the Traffic and Road Safety Act, this Order is made this 6th day of October, 2004. Cap. 361.

1. This Order may be cited as the Traffic and Road Safety (Speed of Motor Vehicle) (Exemption) (No. 7) Order, 2004. Title.

2. A person who drives a motor vehicle and who competes in the Mogas-Castrol Independence Rally, 2004, organised by the Federation of Motor Sports Club of Uganda (FMU), commencing on the 15th October, 2004 and ending on the 17th October, 2004 is exempted from the requirements of section 120 of the Traffic and Road Safety Act, for the duration of that rally. Exemption.
