IN EXERCISE of the powers conferred on the Minister by section 3(1) of the External Trade Act, this Order is made this 15th day of November, 2004.

1. Title

This Order may be cited as the External Trade (Restriction of Importation of Tiger Head Brand Primary Batteries) Order, 2004.

2. Restriction of importation of Tiger Head Batteries

The importation of Tiger Head Brand Primary Batteries is prohibited without a licence granted by the Minister.

3. Penalty

A person who contravenes section 2 commits an offence and is liable, on conviction, to the penalty specified in the External Trade Act.
