National Insurance Corporation Limited Shares to

IN EXERCISE of the powers conferred on the Minister responsible for finance by section 10 of the Stamps Act, this Instrument is made this 15th day of July, 2005. Cap. 342.

1. This Instrument may be cited as the Stamps (Exemption from Stamp Duty) (Transfer of National Insurance Corporation Limited Shares to Corporate Holdings Limited) Instrument, 2005. Title.

2. The stamp duty chargeable under section 2 of the Act on the Instrument specified in the first column to the Schedule to this instrument on the transfer of shares to the person specified in the second column to this Schedule is exempted. Exemption from stamp duty.
