1. This instrument may be cited as the Water Act (General Rates) Instrument, 2006 and shall be deemed to have come into force on the 1st day of July, 2006. Title and commencement date.

2. The rates specified in the First Schedule hereto shall be the rates payable in respect of consumers specified in the Second Schedule therein.

3. The above mentioned rates will be subject to annual indexation against the domestic price index, exchange rate, foreign price index and the electricity tariff. Indexation of the NWSC Tariff.

The indexation will be carried out on a financial year basis and will apply on the 1st July of each year. The indexation will be based upon the following formular.
