**The Traffic and Road Safety (Speed of Motor Vehicle) (Exemption)**  
**(No. 3) Order, 2007.**

*(Under section 175 of the Traffic and Road Safety Act, Cap 361).*

IN EXERCISE of the powers conferred upon the Minister responsible for works and transport by section 175 of the Traffic and Road Safety Act, this Order is made this 30th day of May, 2007.

**1. Title**

This Order may be cited as the Traffic and Road Safety (Speed of Motor Vehicle) (Exemption) (No. 3) Order, 2007.

**2. Exemption**

A person who drives a motor vehicle and who competes in the MOSAC Rally, organised by the Federation of Motor Sports Club of Uganda, commencing on the 8th June, 2007 and ending on the 10th June, 2007 is exempted from the provisions of section 120 of the Traffic and Road Safety Act, for the duration of that rally.

**1. Title.**
