Uganda Revenue Authority, in its effort to improve service delivery to the taxpayers, hereby notifies the public that the categories of taxpayers listed below are exempt from 6% withholding tax for the period 1st JULY 2007 to 30th June 2008.

Government Institutions and all designated withholding agents are therefore advised that 6% withholding tax will not apply to amounts payable to the listed taxpayers in respect of;

- (ii) Supply of services; and
- (iii) Payments by you in respect of CIF value of imported goods.
