The founders of this Party named it the Social Democrats of Uganda (SDU) and it was registered as so in 2004, with its symbol as a torch and Motto "You say we do"

The first National Convention of the SDU sitting at Kampala on 11th November, 2007 resolved to adopt the decision of the National Executive Committee of the SDU to amend the Constitution and most particularly to Change the Name to Social Democratic Party (SDP), Colours to Orange, White and Green. Motto to Justice for all and Symbols to an Orange Rose Flower.
