APPLICATION FOR REVIEW OF SERVICE COST CHARGES NOT PROVIDED FOR IN THE RETAIL TARIFF

The Electricity Regulatory Authority (ERA) has under Section 44 of the Electricity Act 1999, Cap. 145, and the Electricity (Application for Permit, Licence and Tariff Review) Regulations, 2007, S.I. No. 60 of 2007, received an Application for review of Service Cost Charges not provided for in the Retail Tariff from UMEME Ltd.

Pursuant to Section 3.2 of the Distribution Supply Licence, UMEME Ltd engaged a Consultant to carry out a cost of service study. The study was meant to develop a methodology to calculate charges not included in the Retail Tariff which would then form the basis for review of the current Service Cost Charges. Details of the proposed charges are as in the following table:

**The Traffic and Road Safety (Speed of Motor Vehicle) (Exemption)  
Order, 2009.**

*(Under section 175 of the Traffic and Road Safety Act, Cap 361).*

IN EXERCISE of the powers conferred upon the Minister responsible for transport by section 175 of the Traffic and Road Safety Act, Cap. 361 this Order is made this 28th day of January, 2009.

**1. Title.**

This Order may be cited as the Traffic and Road Safety (Speed of Motor Vehicle) (Exemption) Order, 2009.

**2. Exemption.**

A person who drives a motor vehicle and who competes in the CBS Premier Rally 2009, organised by the Federation of Motor Sports Club of Uganda (FMU), taking place on the 15th February, 2009 and going through Festion Cite-Ntawo, Mukono District is exempted from the provisions of section 120 of the Traffic and Road Safety Act, for the duration of that rally.
