



**The Traffic and Road Safety Act (Speed of Motor Vehicle)
(Exemption) (No. 9) Order, 2010.**

(Under section 135 of the Traffic and Road Safety Act, Cap. 361).

IN EXERCISE of the powers conferred upon the Minister of Works and Transport by section 135 of the Traffic and Road Safety Act, 1998, Cap. 361 this Order is made this 23rd day of September, 2010.

1. Title.

This Order may be cited as the Traffic and Road Safety Act (Speed of Motor Vehicle) (Exemption) (No. 9) Order, 2010.

2. Exemption.

A person who drives a motor vehicle and who competes in the Independence rally organised by the Federation of Motor Sports Club of Uganda (FMU) in conjunction with the Southern Motor Club, to be held on the 8th - 10th October, 2010 and passing through the Districts of Masaka and Rakai, is exempted from the provisions of section 120 of the Traffic and Road Safety Act, for the duration of the rally.
