(1) A person who drives a motor vehicle and who competes in the MMC Super Sprint organised by the Federation of Motor Sports Club of Uganda (FMU) in conjunction with Mbarara Motor Club, scheduled to take place on the 27th - 28th November, 2010 and passing through the districts of Kampala, Wakiso and Mukono is exempted from the provisions of section 120 of the Traffic and Road Safety Act, Cap. 361, for the duration of that rally.

(2) A person exempted under sub paragraph (1) shall not exceed a maximum speed of 160 km per hour.
