MINISTERIAL POLICY DIRECTIVE ON THE MERGER
OF UGANDA COMMUNICATIONS COMMISSION (UCC)
AND THE BROADCASTING COUNCIL (BC)

WHEREAS H.E The President of the Republic of Uganda directed the Minister for Information and Communication Technology under Article 99 (1) of 1995 Constitution of the Republic of Uganda to have the Uganda Communications Commission (UCC) and the Broadcasting Council (BC) merged.

AND WHEREAS a decision of Cabinet of April 25, 2007, mandated the Ministry of ICT to constitute a multi institutional committee of which UCC and BC were members to oversee the merger process,


NOW THEREFORE in accordance with the Cabinet decision of April 25, 2007 and in accordance with H.E. the President's directive of 18th December, 2009 given under Article 99 (1) of the Constitution in the exercise of his executive authority as well as the benchmarks of the East African Community in technology and policy convergence in the communications sector, I hereby in exercise of the powers conferred upon the Minister under the Uganda Communications Act Section 11 (2) and the Electronic Media Act Section 9 (5) direct that Uganda Communications Commission and Broadcasting Council establish one administrative structure (transitional body) on this 6th day of December 2010 under the following guidelines:

1. The transitional body shall be headed by an Interim Board appointed by the minister.
2. The primary role of the transitional body shall be to oversee and conclude the process of drafting the law and establishing the merged regulator for both communications and broadcasting in accordance with best practice and international standards.
3. The Interim Board is hereby mandated to form working committees for efficient discharge of its duties.
4. The Interim Board shall carry out the functions of BC and UCC as specified in the Electronic Media Act and the Uganda Communications Act respectively, for the time being until a new law is enacted.
5. The transitional body shall have a secretariat responsible for the day to day operations of the body and shall be headed by an Interim Executive Director appointed by the Minister. The Interim Executive Director shall also be a Member of the Interim Board.
6. The transitional body shall continue to carry out the functions currently executed by UCC and BC until the functions of the merged regulator are provided for by and enacted in the new Law.
7. The two laws that is, the Uganda Communications Act and the Electronic Media Act shall continue to exist and provide the regulatory framework for regulating the communications and broadcasting sectors until a new law is enacted.
8. The Interim board will be in force for a period of one year or such other period as may be determined by the Minister.
9. The Interim Board shall be responsible to the Minister in accordance with the Electronic Media Act and Uganda Communications Act.

10. The membership of the UCC and BC is hereby dissolved by this instrument.

11. The Uganda Communications (Transitional Converged Regulator Policy) Guideline of 15th March 2010 is hereby withdrawn, and replaced by this guideline.

This Policy Guideline may be cited as the Uganda Communications (Transitional Converged Regulator Policy) Amendment Guideline, 2010 and shall come into force on the 6th day of December 2010.

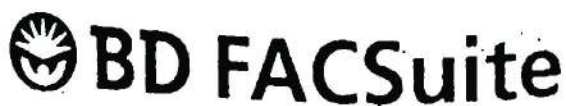
