

**1. Title.**

This Order may be cited as the Traffic and Road Safety (Speed of Motor Vehicle) (Temporary Maximum Speed Limit) (Exemption) (No. 5) Order, 2013.

**2. Exemption.**

A person who drives a motor vehicle or motor cycle and competes in the OILLIBYA MT. ELGON rally, organised by the Federation of Motor Sports Clubs of Uganda (FMU), in conjunction with Motorsport Africa Club (MOSAC) to be held 6th to 8th December, 2013 in the districts of Mbale, Manafwa and Sironko is exempted from the provisions of section 120 of the Traffic and Road Safety Act and Traffic and Road Safety (Speed Limits) Regulations, S.I. No. 33 of 2004 for the duration of the rally.

**3. Maximum speed limit.**

**The Pharmacy and Drugs (Prescription of Forms) Regulations, 2013.**

*(Under section 13 of the Pharmacy and Drugs Act, Cap 280)*

IN EXERCISE of the powers conferred upon the Minister by section 13 of the Pharmacy and Drugs Act, Cap 280, these Regulations are made this 4th day of December, 2013.

**1. Title.**

These Regulations may be cited as the Pharmacy and Drugs (Prescription of Forms) Regulations, 2013.

**2. Commencement.**

These Regulations shall be deemed to have come into force on 1st July, 2012.

**3. Form of register.**

A register of pharmacists required to be kept under section 13(2) of the Act shall be in the form specified in the First Schedule to these Regulations.

**4. Application for registration.**

(1) The application under section 13(2) of the Act for the registration as a pharmacist shall contain—

- (a) the name and address of the applicant;
- (b) the qualifications of the applicant (being one or more of the qualifications set out in section 7(1) of the Act;

- (c) the date and place of birth of the applicant;
- (d) whether the applicant is at the date of application subject to any disqualifications set out in section 8 of the Act; and
- (e) whether the applicant's previous registration has been cancelled or suspended, and if so, giving proof that he or she is entitled to reapply for registration.

(2) The application shall be accompanied by—

- (a) duly authenticated copies of the degree certificate and transcript certified by the issuing Institution bearing an original stamp;
- (b) evidence of successful completion of practical training;
- (c) authenticated results of the pre-registration examinations; and
- (d) any other document as may be prescribed by the Pharmacy Board.

(3) A certificate of registration issued under section 13(2) of the Act shall be in the form specified in the Second Schedule.

## **5. Appearance before the board.**

(1) The applicant shall appear before the board, if the board so directs, at such time and place as may be notified to him or her by the registrar.

(2) The registrar shall notify the applicant of the decision of the board in respect of his or her application.

## **6. Fees.**

The applicant shall pay for the certificate of registration the fees as specified in the Third Schedule.

**7. Repeal of the Pharmacy and Drugs (Prescription of Forms) Regulations SI 280-1.**

The Pharmacy and Drugs (Prescription of Forms) Regulations SI 280-1 is repealed.

*(Under Sections 49 and 82 of the Uganda Citizenship and Immigration  
Control Act, Cap. 66)*

IN EXERCISE of the powers conferred upon the Minister by Sections 49 and 82 of the Uganda Citizenship and Immigration Control Act, (Cap. 66) and in consultation with the National Citizenship and Immigration Board, these Regulations are made this 8th day of November, 2013.

**1. Title.**

These Regulations may be cited as the Uganda Citizenship and immigration Control (fees) Regulations, 2013.

**2. Commencement.**

These regulations shall be deemed to have come into force on the 1st day of July 2013.

**3. Fees.**

The fees specified in the second column of the Schedule to these Regulations shall be the fees for the purposes specified respectively in the first column of that Schedule.

**4. Revocation of SI No. 53 of 2009.**

The Uganda Citizenship and Immigration Control (Fees) Regulations, 2009, SI No.53 of 2009 is revoked.
