



The Stamps (Exemption from Stamp Duty) (Increase of Issued Share Capital by Uganda Development Bank Limited) Instrument, 2014.

(Under section 10 of the Stamps Act, Cap. 342).

IN EXERCISE of powers conferred upon the Minister responsible for Finance under section 10 of the Stamps Act, this Instrument is made this 26th day of February, 2014.

1. Title.

This Instrument may be cited as the Stamps (Exemption from Stamp Duty) (Increase of Issued Share Capital by Uganda Development Bank Limited) Instrument, 2014.

2. Exemption from stamp duty.

The stamp duty chargeable under section 2 of the Act and payable by Uganda Development Bank Limited on increase of its issued share capital from one hundred billion Uganda shillings to five hundred billion Uganda shillings is exempted.
