## **The Electricity (Licence Fees) (Amendment) Regulations, 2014.**

*(Under Sections 10 (c) 10(n) and 119 of the Electricity Act, Cap. 145).*

IN EXERCISE of the powers conferred upon the Electricity Regulatory Authority by Sections 10 (c), 10 (n) and 119 of the Electricity Act, Cap. 145 these Regulations are made this 16th day of May, 2014.

### **1. Title.**

These Regulations may be cited as the Electricity (Licence fees) (Amendment) Regulations, 2014.

### **2. Commencement.**

These Regulations shall be deemed to have come into force on the 5th day of May, 2011.

### **3. Revocation of SI. No. 24 of 2011.**

The Electricity (Licence Fees) (Amendment of Schedule) Instrument, 2011 is revoked.

### **4. Amendment of the Schedule to the Electricity (Licence Fees) Regulations, 2003, SI. No. 20 of 2003.**

For the Schedule to the Electricity (Licence Fees) Regulations, 2003, SI. No.20 of 2003 there is substituted the following—
