WHEREAS the Government has approved the introduction into Parliament of Bills for Acts to make provision for the imposition and alteration of certain taxes and duties, the short titles of which are—

- (a) Excise Duty Bill, 2013;
- (b) the Lotteries and Gaming Bill, 2013;
- (c) the Stamps Bill, 2013;
- (d) the Tax Procedure Code Bill, 2014;
- (e) the Income Tax (Amendment) Bill, 2014;
- (f) the Value Added Tax (Amendment) Bill, 2014;
- (g) the Finance Bill, 2014;
- (h) the Stamps (Amendment of Schedule) Instrument, 2014; and
- (i) the Excise Tariff (Amendment) Bill, 2014.

AND WHEREAS if those Bills, which are published on the 13th December, 2013, 14th March, 2014 and 27th day of June, 2014 respectively were passed into law, certain taxes and duties would be charged, levied and collected;

NOW THEREFORE, in exercise of the powers conferred upon the Minister by section 1 of the Taxes and Duties (Provisional Collection) Act, this Order is made this 26th day of June, 2014.

1. Title and commencement.

This Order may be cited as the Taxes and Duties (Provisional Collection) Order, 2014 and shall come into force on the 1st day of July, 2014.

2. Provisional collection.

There shall be charged, levied and collected on the goods and services affected by those Bills, the taxes and duties, which would be payable, if those Bills were passed into law and came into operation in place of the taxes and duties payable on those goods and services under the existing laws.
