POLICY DIRECTION ISSUED TO THE ELECTRICITY REGULATORY AUTHORITY (ERA) WITH RESPECT TO THE DEVELOPMENT OF KARUMA, ISIMBA AND AYAGO HYDROPOWER PLANTS.

(Under Section 17 of the Electricity Act, 1999 – Cap 145 laws of Uganda)

IN EXERCISE of the powers conferred upon the Minister by Section 17 of the Electricity Act, 1999, this policy direction is issued this 5th day of September, 2014.

PREAMBLE

1. Government of Uganda has prioritized development of electricity infrastructure as a key element to catalyse socio-economic development. Whereas Independent Power Producers (IPPs) have contributed to the development of Uganda's power sector, it is noted that the output tariffs from power plants owned and operated by Independent Power Producers (IPPs) are relatively high. High tariffs do not support investment in other sectors of the economy. Government Policy is to address the issue of high tariffs and make electricity available with good reliability, adequate capacity and at affordable tariffs to support socio – economic development.
2. Consequently, Government has prioritized the development of the 600MW Karuma hydropower plant, the 183MW Isimba hydropower plant and the 600MW Ayago hydropower plant as Government public funded projects to keep tariffs at affordable levels. Government has conducted the pre-feasibility studies, the full feasibility studies with detailed designs for the first two projects (Karuma and Isimba) and is developing the projects utilizing resources allocated under the Energy Fund together with other funding from development partners. For the 600MW Ayago hydropower plant, pre-feasibility studies are complete and the feasibility study is at an advanced stage. Government is in the process of concluding funding from China Exim Bank utilizing Chinese contractors. The contractors are Sinohydro Limited for the 600MW Karuma hydropower plant with associated evacuation transmission lines and substations; China International Water and Electric Corporation (CWE) for the 183MW Isimba hydropower plant and the Isimba Bujagali 132kV evacuation line; and China Ghezouba Group Company Limited (CGGC) for the 600MW Ayago hydropower plant and its evacuation line.

3. Government has appointed Uganda Electricity Generation Company Limited (UEGCL) as its representative in overseeing the construction works and later as owner of the hydropower plants and also appointed UETCL to oversee the construction of the evacuation lines and related substations.
4. The National Environment Management Authority (NEMA) clearances and clearance for the Resettlement Action Plans (RAPs) have been obtained for the three projects as Government funded projects. Implementation of the RAPs is under implementation by Government.

POLICY DIRECTION

5. The Electricity Regulatory Authority is hereby directed to note and observe the following policy direction:
 - (a) All studies for the three projects (the 600MW Karuma hydropower plant, the 183MW Isimba hydropower plant and the 600MW Karuma hydro power plant together with their interconnection lines) have been conducted by Government and are not subject to approval by the Electricity Regulatory Authority (ERA).
 - (b) Procurement of all services for the three projects (feasibility studies, construction works and construction supervision services) are done under the Public Procurement and Disposal of Public Assets (PPDA) Act. The Electricity Regulatory Authority (ERA) licensing procedures are therefore not applicable to the procurement of these services.
 - (c) Uganda Electricity Generation Company Limited (UEGCL) will apply for the licenses after attainment of financial closure for the projects under which the generation plants will be operated.
 - (d) Applicable tariffs for the 600MW Karuma hydropower plant, the 183MW Isimba hydropower plant and the 600MW Ayago hydropower plant will be determined by ERA as provided for in the Electricity Act 1999, based on financing terms to be agreed upon to cover costs of each of the plants as well as operation and maintenance costs. Financing costs as well as operation and maintenance costs shall be availed at the time of application for licenses.
 - (e) ERA is prohibited from issuing any permit or a license for purposes of conducting any studies on Karuma, Isimba and Ayago hydropower sites since these have been concluded by Government of Uganda.






