1.0. INTRODUCTION

With reference to a High Court Order dated 20th day of June, 2016, a boundary survey and subdivision was carried out to verify the physical boundaries of Kyaggwe Block 113, Plots 9, 457, 458 and subdivide according to the respective portions as sold by the court Bailiff.

2.0 LOCATION AND ACCESS

The subject property is located in Kyaggwe Block 113. Plots 9, 457 and 458 situated at approximately eighteen kilometers from Kampala City Center. Access to the subject land property is via Jinja road for approximately fifteen Kilometers passed Century Bottling Company at Kampala Industrial Business Park Namanve. Take a right turn onto a marrum road opposite Jomayi stones and proceed for approximately one kilometer upto plot 9. Other plots 457 and 458 can be accessed through Plot 9.

3.0 CONTROL AND DATA USED

Current cadastral prints and respective area schedules were obtained from Mukono Land office, a copy of the original Cartridge map and land information system data (Coordinates) were obtained from the department of surveys and mapping, Entebbe. These were used to control the survey.

4.0 INSTRUMENTATION

The following instruments were used in the survey exercise

- A set of GPS System (Leica 1200 receiver)
- Tape measure.
- Iron metal bars

5.0: METHODOLOGY.

A Reconnaissance survey was first carried out on and around the site to identify some of the corner mark stones of the plots in question. Three of them were found firmly fixed on the ground and verifiable on the print.

The GPS receiver was set up on one of the verifiable mark stones. Maps were coordinated and using a GPS Rover, the boundaries were set out (established) while fixing temporary pegs at all corner boundary points where old marks were found missing.

Using AutoCAD software, the subject plot boundaries were plotted and the respective subdivision layout was developed/designed according to the court order attached. The boundary coordinates of the subdivisions were retrieved and set out on ground while fixing Corner Markstones.

A Job Record Jacket (JRJ) for the subdivisions was computed. Checked and approved for Submission in the land office for deed plan preparation.

6.0: RESULTS AND OBSERVATIONS.

The survey was carried out successfully and it was observed that;

- The land for Kyaggwe Block 113, Plots 9, 457 and 458 is clearly available and measures approximately 152.766 hectares (377.5 acres), 69.807 hectares (172.5 acres) and 20.235 hectares (50.00 acres) respectively and gives a total of approximately 242.808 hectares (600.02 acres) which is just part of the entire **778.65** acres in the Estate of the late H.H. Daudi Chwa at Nantabulirwa under FC 20437.
- Kyaggwe Block 113, Plot 9 has multiple interests as observed by a very high number of squatters with permanent developments such as residential houses, commercial premises, access road networks, Schools among others.
- At the time of inspection, it was observed that Kyaggwe Block 113, Plot 9 has over twenty four (24) subdivisions among which others have Certificates of Titles under leasehold tenure system and hence Plot 9 has changed its reference to Kyaggwe Block 113, plot 1089 as illustrated in the area schedule attached hence Justifying the existence of Certificate of Title for the same.
- Kyaggwe Block 113, Plot 457 has no structural developments, its easily accessible and has physically defined boundaries that resonate with the land use partners on ground.
- Plot 457 was subdivided into plots 477, 478 and 479 according to one of the cadastral maps obtained from Mukono Land Office, though these are not reflected on the ground.
- Kyaggwe Block 113, Plot 458 has clear boundaries on ground, however, according to the area schedule and ground measurements, its acreage is part of the 72.971 hectares (180.32 acres) for Plot 549 and according to the development partners on ground, the Cartridge map and the established boundary beacons, both plots were a single parcel and part of the entire **778.65** acres in the Estate of late H.H. Daudi Chwa at Nantabulirwa under FC 20437.
- Kyaggwe Block 113, Plot 549 has six subdivisions of plots 550, 551, 552, 553, 554 and 555 measuring a total of approximately 52.731 hectares according to the cadastral map and these subdivisions are not physically verifiably on ground. Thus making it very clear that Plots 457 and 549 should be amalgamated and treated as one entity in this regard.
- With reference to the copy of the cartridge map attached, Plots 1 and 2 measuring 14.1 hectares (34.84 acres) and 3.68 hectares (9.10 acres) respectively are a recent creation out of the Estate of the Late H.H. Daudi Chwa as explained below:

The total acreage of the Estate of the late H.H. Daudi Chwa at Nantabulirwa measures 778.65 acres, according to the cartridge map PC 20437. The total size of plots 9, 457, 458 and 549 is 734.52 acres and this gives a discrepancy of approximately 43.89 acres from 778.65 acres which is the approximate size of the mentioned creations, plots 1 and 2 above.

The area schedule Records from Mukono land office presents plots 1 and 2 measuring 4.0 acres and 3.0 acres belonging to Mikaeri Kaddu and Disani Mayega respectively which is an outright contradiction with the cartridge map in both size and status of ownership.



Basing on the format and units of labeling on the original Cartridge map, it only changes units of linear dimensional measurements from feet to meters at plots 1 and 2 and hence proof for a recent creation.

- According to the area schedule, the mutation of plots 458 and 457 were requested for by Uganda Land Commission and plot 549 by Uganda Investment Authority and the subdivision of plot 9 was authorized by H.H. The Kabaka.
- With the above observations, plots 1, 2, 9, 457, 458 and 549 stem their origin from the Estate of the Late H.H. Daudi Chwa based on dimensions, shapes, acreage and their physical locations.
- As ordered by Court to subdivide the above described land according to the respective portions as sold by the court bailiff Moses Mutesasira of the Mutesasira Associates and Bailiffs under a warrant of attachment and sale issued on the 12th day of April, 2016 Vide EMA No. 95 of 2016, the survey exercise was done to completion as seen in the JRJ attached in the appendix.

7.0 RECOMMENDATION

With the above results and observations, we recommend that:

- As a principle of eliminating double ownership and double title registration, all the Existing certificates of titles on the estate of the late H.H. Daudi Chwa at Nantabulirwa emanating from FC 20437 should be cancelled and original status reinstated through legal procedures as provided for in the land Registration Act.
- A detailed intervention to identify stakeholders with bonafied and lawful interests in the subject pieces of land should be conducted by the current administrator (Mutesasira Associates and Bailiffs) for negotiations aimed at revising the terms and conditions of ownership where applicable.
- Plots 457, 458 and 549 are amalgamated into a single plot for easy planning and development as proposed in the attached JRJ.
- Caveats be placed on all the existing certificates of titles on the said estate as soon as possible to avoid further subdivisions and transactions by the current title holders.
- For purposes of tracing boundaries of the estate of the late H.H. Daudi Chwa, Plots 1 and 2 mentioned above should be considered.

8.0 CONCLUSIONS:
