3. EMMANUEL KATAMBA





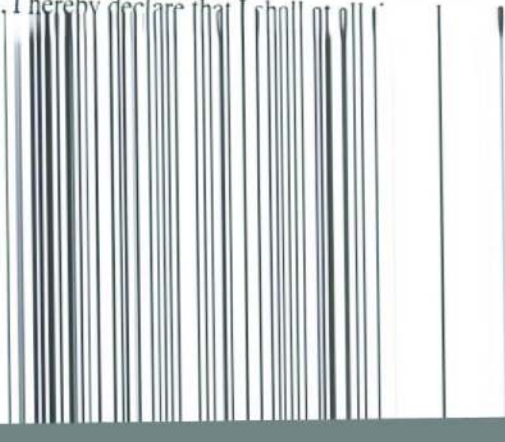
