**APPOINTMENT OF NOMINATION DAYS FOR A
BYE-ELECTION OF UGANDA'S REPRESENTATIVE
TO THE EAST AFRICAN LEGISLATIVE ASSEMBLY**
(Under Rule 8 of Appendix B of the Rules of Procedure of Parliament)

The Speaker of the East African Legislative Assembly pursuant to Section 8(1) of the East African Legislative Assembly Elections Act, 2011 notified the Speaker of Parliament of Uganda on 18th May, 2021 of a vacancy in EALA following the demise of one of Uganda's nine representatives to the East African Legislative Assembly.

Pursuant to the Authority vested in the Clerk to Parliament under subparagraph 3(1) of the Rules of Procedure for the election of Members of the East African Legislative Assembly as contained in Appendix B to the Rules of Procedure of the Parliament of Uganda,

Notice is hereby given that the 21st and 22nd day July, 2021 are the dates appointed during which the nomination of candidates for the bye-election shall take place.

Notice is further given that nomination forms may be obtained from the Office of Parliament. In accordance with paragraph 7 of the Rules of Procedure for the Election of Members of the East African Legislative Assembly as contained in Appendix B to the Rules of Procedure of the Parliament of Uganda, a candidate is required to pay a nomination fee of Uganda Shillings three million. Completed nomination forms of candidates shall be submitted to the Office of the Clerk to Parliament not later than 10:00 hours in the forenoon on Friday 23rd July, 2021.

The Bye-election shall be held on Monday 26th July, 2021 starting at 10:00hrs in the forenoon.

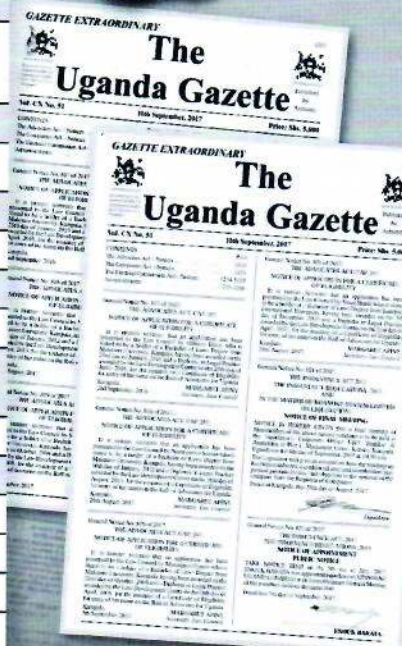
