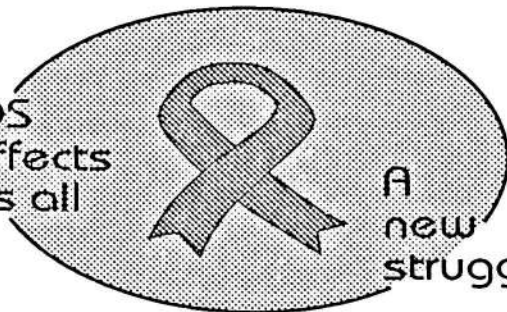

The proposed township is located to the north west of Whittlesea.

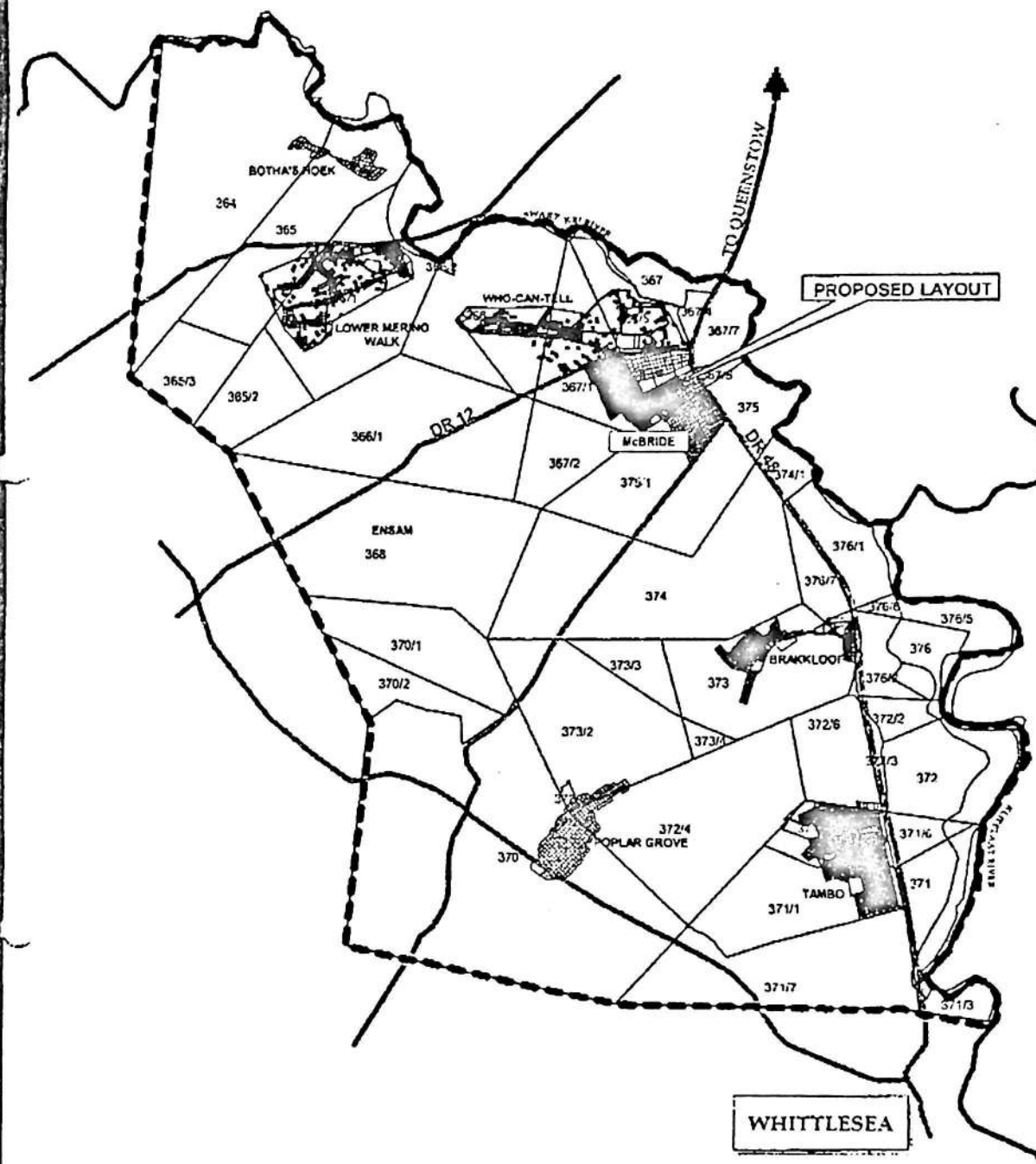

Point of Instability and Necessary Conditions

14. The Board is composed of six individuals, each appointed by the City Council, and shall serve for a term of six years. The first term of the Board shall be for the years 1990 to 1996. The Board shall have the power to make and amend the rules and regulations of the program, with the prior written approval of the City Council.
