

## NOTICE IN TERMS OF SECTION 15 (1) OF THE UPGRADING OF LAND TENURE RIGHTS ACT (ACT No. 112 OF 1991)

I, Gugile Ernest Nkwinti, Member of the Executive Council for Housing, Local Government and Traditional Affairs, duly authorized thereto, hereby declare in terms of section 15 (1) of Act No. 112 of 1991, the township on the undermentioned properties to be formalized townships for the purposes of section 2 of Chapter 1 of the said Act, No. 112 of 1991:

**Townships situated on—**

Portion 1 of the farm Thornhills Location No. 388, Administrative District Bathurst, Province of the Eastern Cape.

*Extent:* 83,9401 (eight three comma nine four zero one) hectares.

*Held by:* Title Deed No. T24686/1991;

Portion 6 (a portion of Portion 4) of the farm Thornhills Location No. 388, Administrative District Bathurst, Province of the Eastern Cape.

*Extent:* 41,1712 (four one comma one seven one two) hectares.

*Held by:* Title Deed No. T24686/1991;

A portion of Erf 1511, Nkwenkwezi, Municipality of Port Alfred, Eastern Cape Province.

*Held by:* Certificate of Registered Title No. T12277/1986.

As will more fully appear from General Plans Nos. 8691/92, 10680/93, 8283/96, 10678/93, 7873/96, 1399/95, 2682/95, 1646/96, 2680/95, 5440/97, 8278/95, 2430/96, 7178/97, 5497/98, 3795/99, 4309/99, which have been approved in terms of the provisions of the Less Formal Township Establishment Act, No. 113 of 1991, and which shall be registered in accordance with the provisions of section 46 of the Deeds Registries Act, 1937 (Act No. 47 of 1937), with regard to the provisions of Act No. 113 of 1991, and in respect of which land tenure rights mentioned in Schedule 1 of Act No. 112 of 1991, have been granted.
