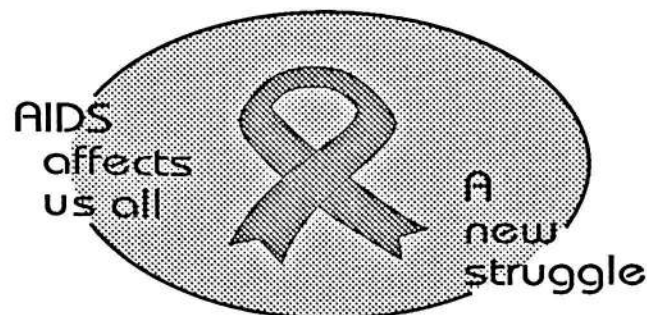

DATE FOR THE HOLDING OF COMMUNITY MEETINGS (IMBIZO) BY, AND FOR THE PURPOSES OF SELECTION OF CANDIDATES FOR NOMINATION OF TWO MEMBERS REPRESENTING, RHARHABE REGION (PHASE 1)

Under the powers vested in me by rule 2 of the Rules relating to the Nomination of Members, and the Composition, of the House of Traditional Leaders, I, Makhenkesi Stofile, Premier of the Province of the Eastern Cape, hereby determine 10 April 2001 as being the date on which community meetings (imbizo) shall be held by the traditional authorities of the Rharhabe region for purposes of selecting candidates from amongst whom two members of the House of Traditional Leaders for the Rharhabe region will be nominated in terms of rule 3 of the said Rules. Under the powers vested in me by rule 4 of the Rules relating to the Nomination of members, and the composition, of the House of Traditional Leaders, I, Makhenkesi Stofile, Premier of the Province of the Eastern Cape, hereby determine 17 April 2001 as being the date on which the Rharhabe electoral college constituted in terms of rule 3(2) of the said Rules will meet in King William's Town for purposes of nominating two traditional leaders who will become members of the House of Traditional Leaders in terms of the said Act and Rules (This is Phase 2 of a two-phased process.)
